

# PUBLIC NOTICE

## THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (BRIDLEWAY NUMBER 4 (PART), COLD BRAYFIELD) PUBLIC PATH DIVERSION ORDER 2008 (NO 2)

On 18 December 2008 the Council of the Borough of Milton Keynes confirmed the above Order made under Section 119 of the Highways Act 1980.

The Order as confirmed will divert that part of public Bridleway Number 4 Cold Brayfield, Milton Keynes from point A at OS Grid reference SP 492780 252152 in a north-westerly direction for a distance of approximately 130 metres to point D at OS Grid Reference SP 492653 252179; to point B at OS Grid Reference SP 492781 252156 in a north-westerly direction for a distance of approximately 130 metres to point C at OS Grid Reference SP 492657 252187. The bridleway shall have a width of 3.5 metres throughout, consisting of a 1.2 metre wide hoggin surface with grass verges to both sides.


A copy of the confirmed Order and map have been placed and may be seen free of charge at Milton Keynes Council, Civic Offices, 1 Saxon Gate East, Milton Keynes between 9.00am and 5.00pm on any working day, at Milton Keynes Library, 555 Silbury Boulevard, Milton Keynes, and at Olney Library, High Street, Olney, Milton Keynes during normal opening hours. Copies of the Order and map may be purchased from Milton Keynes Council, Civic Offices at the price of £3.00.

The Order came into force on 13 November 2008, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from publication of this notice, make an application to the High Court.

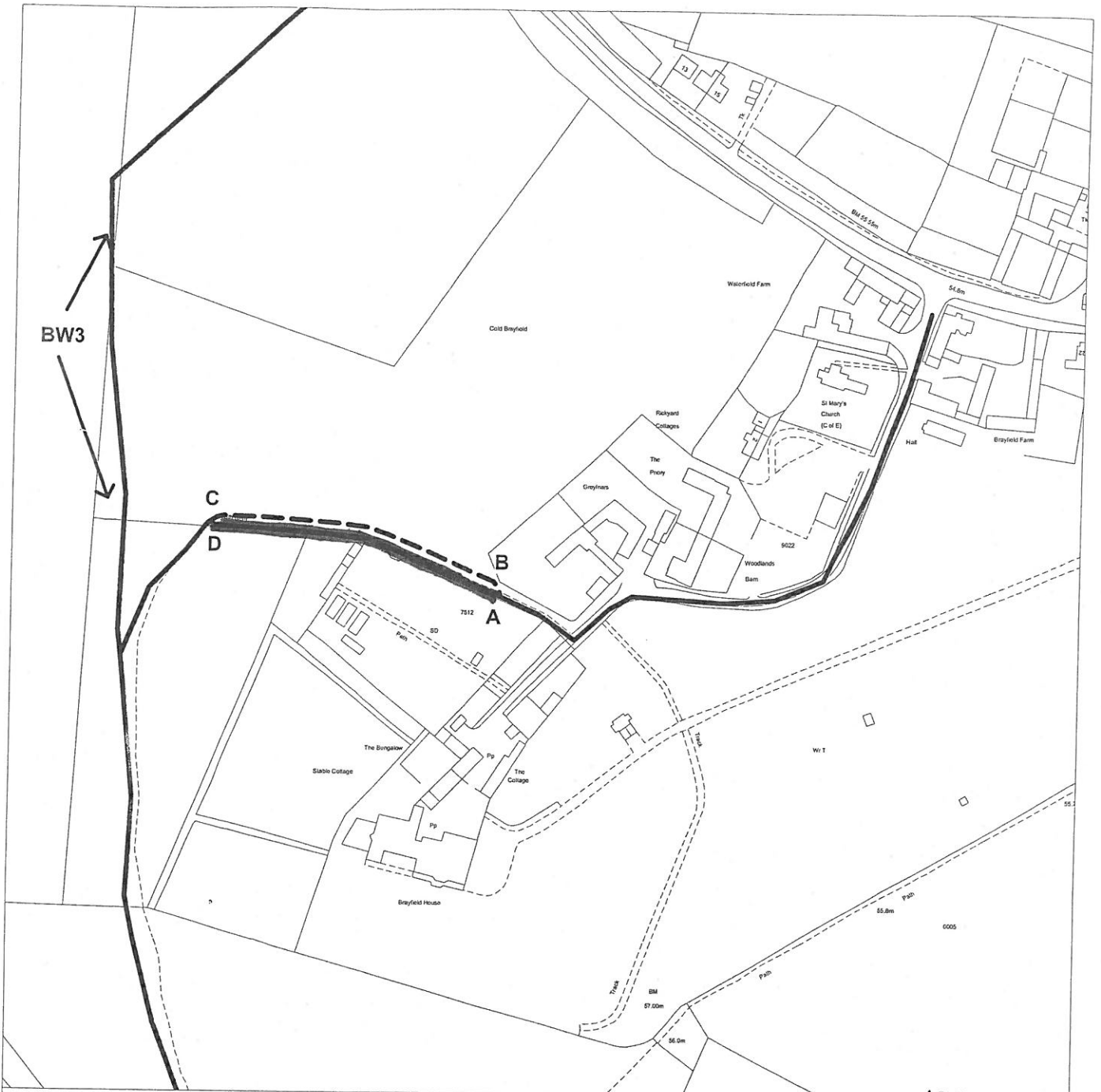
