PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53A(2)

THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (MOULSOE FOOTPATH 14 (PART)) PUBLIC PATH DIVERSION ORDER 2022

This Order is made by the Council of the Borough of Milton Keynes under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert that part of the footpath to which this Order relates in order to enable development to be carried out in accordance with planning permission reference 21/00999/OUTEIS granted under Part III of the Town and Country Planning Act 1990, namely the planned residential and mixed use development of land, as part of the Milton Keynes East development, land east and west of A509 London Road, Newport Pagnell, Milton Keynes.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement for Milton Keynes require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

BY THIS ORDER:

- 1. The Public Footpath over the land shown by a bold black continuous line on the attached Order plan and described in Part 1 of the Schedule to this Order ('the Schedule') shall be diverted as provided below and the Definitive Map and Statement for Milton Keynes shall be modified.
- There shall be created to the reasonable satisfaction of the Council of the Borough of Milton Keynes an alternative highway for use as a replacement for the said section of footpath as provided in Part 2 of the Schedule and shown by a bold black dashed line on the attached Order plan.

- 3. The diversion of the footpath shall have effect on the date on which Milton Keynes Council certifies that the terms of Article 2 above have been complied with and upon the occurrence of that diversion the Definitive map for Milton Keynes shall be modified by deleting from it the path or way referred to in Article 1 of this Order and the path or way referred to in Article 2 of this Order shall be added to it and the definitive statement shall be modified as described in Part 3 of the Schedule.
- 4. Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

SCHEDULE

PART 1

Description of site of existing path or way

Existing Public Footpath Moulsoe 14 (Part)

From point A at OS Grid Reference SP 88102 41636 in a general north easterly direction for approximately 206 metres to point B at OS Grid Reference SP 88260 41766, then in a general north north easterly direction for 274 metres to point C at OS Grid Reference SP 88318 42034.

This existing footpath has a length of approximately 480 metres and a width of 1 metre throughout and is indicated by the points stated above on the Order plan by a bold black continuous line.


PART 2

Description of site of alternative highway

Alternative Public Footpath Moulsoe 14 (Part)

From point A at OS Grid Reference SP 88102 41636 in a general north easterly direction for 325 metres to point D at OS Grid Reference SP 88212 41925, then in a general north westerly direction for 136 metres to point E at OS Grid Reference SP 88147 42030, then continuing in a general north easterly direction for 11 metres to point F at OS Grid Reference SP 88154 42039, then in a general easterly direction for 168 metres to terminate at point C at OS Grid Reference SP 88318 42034

The alternative footpath will have a length of approximately 640 metres and a width of 3 metres throughout and is indicated by the points stated above on the Order plan by a bold black dashed line.

Modification of Definitive Statement Variation of Particulars of Path or Way

Moulsoe Footpath 14

Add:-

From: SP 88082 41642 To: SP 87966 42673

From junction with Campbell Park Footpath 1 on bridge over M1, generally north easterly with deviations for approximately 640 metres reaching a brook. Then travelling northerly for approximately 290 metres to Moat Cottage before travelling north-west for 436 metres to terminate at junction with at Newport Pagnell Footpath 7 the A422.

Width: 3 metres between SP 88102 41636 and SP 88318 42034.
