**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (UNRECORDED
FOOTPATH - PARISH OF BROUGHTON AND MILTON KEYNES)
DEFINITIVE MAP MODIFICATION ORDER 2012**

THIS ORDER IS MADE BY the Council of the Borough of Milton Keynes ("the Authority") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Part 2 (Buckinghamshire County Council, Milton Keynes Borough Council Area Only) Definitive Map and Statement ("the Definitive Map and Statement") requires modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act, namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the Definitive Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the Definitive Map and Statement relates, being a right of way to which this part of the Act applies.

The Authority has consulted with every local authority whose area includes the land to which this Order relates. The Council of the Borough of Milton Keynes hereby orders that:

1. For the purposes of this Order the relevant date is 1st July 2006.
2. The Part 2 (Buckinghamshire County Council, Milton Keynes Borough Council Area Only) Definitive Map and Statement shall be modified as described in the Schedule and shown on the map attached to this Order ("the Order Map").
3. This Order shall take effect twenty eight (28) days from the date it is confirmed.
4. This Order may be cited as The Council of the Borough of Milton Keynes (Unrecorded Footpath - Parish of Broughton and Milton Keynes) Definitive Map Modification Order 2012.

**Modification of Part 2 (Buckinghamshire County Council, Milton Keynes
Borough Council Area Only) Definitive Map
Description of public footpath to be added**

The route commences at the end of the redway adjacent to the Sustrans cycle route known as 'Route 51' at the point marked A on the Order Map at National Grid Reference ("NGR") SP487763/238858. The route then proceeds in an

easterly direction for a distance of 23 metres before curving in a southerly direction for a further distance of 14 metres to the point marked B on the Order Map at NGR SP487796/238849. The route then runs in an easterly direction for a distance of 592 metres where it joins the underpass to the highway known as Brickhill Street (V10) at the point marked C on the Order Map at NGR SP488364/238804. The route has a total length of 629 metres and a width of 1.8 metres throughout. The public footpath shall be known as Footpath No.32 in the Parish of Broughton and Milton Keynes.

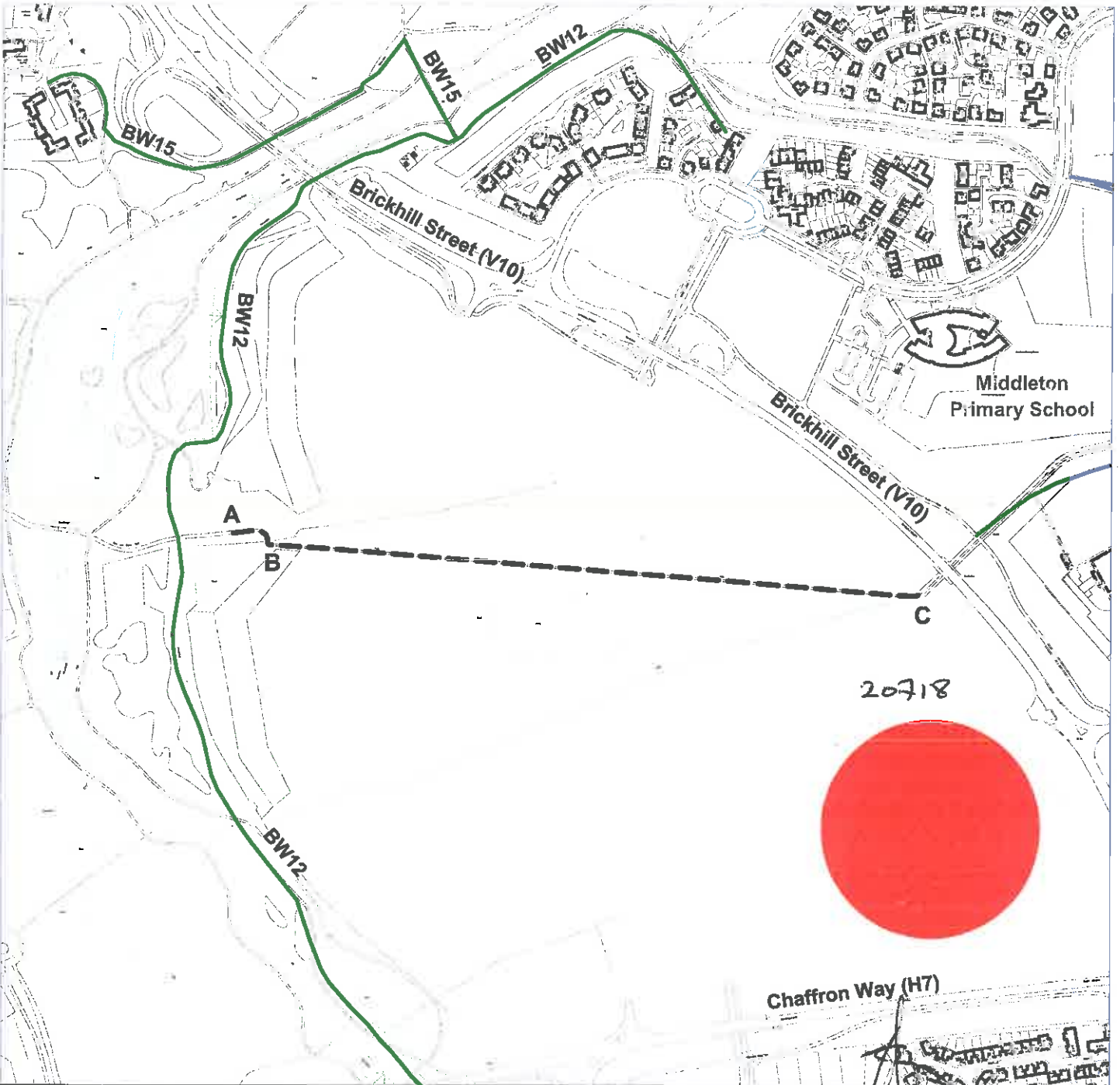
