MILTON KEYNES SITE ALLOCATIONS PLAN SCHEDULE OF MAIN MODIFICATIONS

Planning and Compulsory Purchase Act 2004 The Town and Country Planning (Local Development) (England) Regulations 2012

Milton Keynes Council has published a Site Allocations Plan: Schedule of Main Modifications for a six week period of consultation from **Wednesday 21st February - Wednesday 4th April 2018**.

The Site Allocations Plan (SAP) was submitted to the Planning Inspectorate for examination in April 2017. Following examination hearings held on 12-13 September 2017, the Inspector invited the Council to submit, for his consideration, a schedule of proposed Main Modifications to the SAP which he considered to be necessary to make the plan sound.

Following further correspondence between the Council and the Inspector to finalise the schedule of modifications, the schedule will now be subject to public consultation.

Title of Document: Milton Keynes Site Allocations Plan: Schedule of Main Modifications

Subject matter: The Milton Keynes Site Allocations Plan has been prepared pursuant to the 2013 Core Strategy in order to support the development strategy of the borough and supplement housing land supply. The schedule outlines a number of main modifications to the submission version of the plan that are considered necessary for the plan to be found sound.

Area covered: The Site Allocations Plan covers the whole of Milton Keynes Borough administrative area, although the allocations made in the Plan are solely within the existing Milton Keynes urban area. .

Period of publication: Wednesday 21st February – Wednesday 4th April 2018.
