2014) VARIATION ORDER 2018**

The Council of the Borough of Milton Keynes (“the Council”) in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

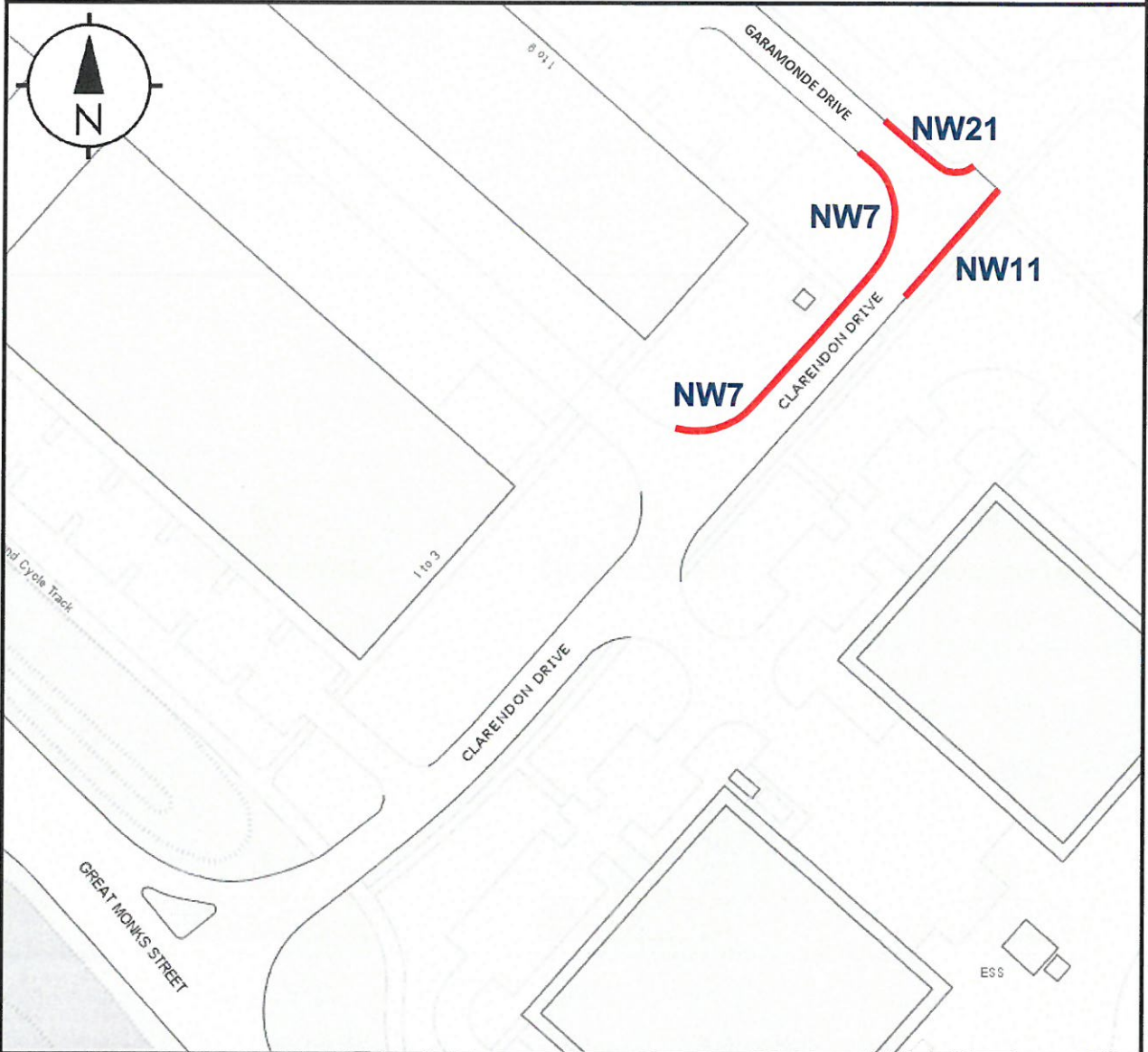
1. This Order shall come into operation on the 23rd day of July 2018 and may be cited as “The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Road, Wymbush) (Prohibition of Waiting) Order 2014) Variation Order 2018”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Road, Wymbush) (Prohibition of Waiting) Order 2014 and form part of that Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Various Road, Wymbush) (Prohibition of Waiting) Order 2014 (“The Principal Order”) is varied as provided by the following provisions of this Order:-

NW7 From a point 132.0 metres north-east of the north-eastern kerbline of V5 Great Monks Street, for a distance of 76.2 metres in a north-easterly then north-westerly direction

7. Item NW11 in Schedule 1 of the principal Order is hereby revoked and replaced by the following:-

**THE JUNCTION OF CLARENDON DRIVE AND GARAMONDE DRIVE
SOUTH-EAST SIDE**

NW11 From a point 171.4 metres north-east of the north-eastern kerbline of V5 Great Monks Street, for a distance of 28.4 metres in a north-easterly direction

8. Item NW21 in Schedule 1 of the principal Order is hereby revoked and replaced by the following:-

**THE JUNCTION OF CLARENDON DRIVE AND GARAMONDE DRIVE
NORTH-EAST SIDE**

NW21 From a point 29.2 metres north-west of the south-eastern kerbline of Clarendon Drive, for a distance of 20 metres in a south-easterly then north-easterly direction
