David,

At tomorrow afternoon's Milton Keynes Local Plan examination session, the Inspector has asked this Council to confirm the soundness of the strategic site housing allocations including for policy SD15 land at Eaton Leys including the planning status of site and heritage assets in relation to Magiovinium.

I appreciate things have moved on since your written statement on this site, copy attached, was submitted to us. Eaton Leys is now a committed housing site as outline planning permission has been granted for it, a management plan has been prepared, your letter of 10 December attached raised no objection to the application on heritage grounds and conditions for this site are being discharged.

However, as far as our Local Plan is concerned we are proposing to modify policy SD15 as shown in the table below and amend the policies map to amend the boundaries of the Eaton Leys housing site to exclude the scheduled Monument, see attached plan.
