

# **MILTON KEYNES EAST DEVELOPMENT FRAMEWORK SUPPLEMENTARY PLANNING DOCUMENT**

## **GUIDANCE NOTE FOR RESPONDENTS**

**Consultation Period:**

**7 August – 16 October 2019**

## Introduction

The Milton Keynes East Development Framework Supplementary Planning Document will guide future applications for development within the Milton Keynes East Strategic Urban Extension which has been allocated in Plan:MK 2016-2031. The allocation covers an area of land approximately 440 hectares in size encompassed by the M1 to the west, the A422/A509 to the north, and Moulsoe and the wider rural area to the east.

The Supplementary Planning Document will support policies in Plan:MK and will be considered a material consideration in the determination of planning applications submitted to the Council.
