Milton Keynes Council has published the Draft Milton Keynes East Development Framework Supplementary Planning Document for a six-week period of consultation from **7 August 2019 – 16 October 2019**.

The document is now subject to public consultation.

Title of Document: Draft Milton Keynes East Development Framework Supplementary Planning Document

Subject matter: The Milton Keynes East Development Framework Supplementary Planning Document will guide future applications for development within the Milton Keynes East Strategic Urban Extension which has been allocated in Plan:MK 2016-2031. The SPD will support policies in Plan:MK and will be considered a material consideration in the determination of planning applications submitted to the Council.

Area covered: The document relates to a land use allocation within the borough of Milton Keynes as set out in Plan:MK 2016-2031. The allocation covers an area of land approximately 440 hectares in size encompassed by the M1 to the west, the A422/A509 to the north, and Moulsoe and the wider rural area to the east.

Period of publication: **7 August 2019 – 16 October 2019.**
