1. This table of fees is made under the Milton Keynes Council Cemeteries Regulations and shall come into force on the **8th April 2019**

2. The fees, payments and sums set out below apply where the persons to be interred or in respect of whom the right is granted is, or immediately before his death was, an inhabitant or parishioner in the District of Milton Keynes or, in the case of a still-born child, where one of the parents is, or at the time of interment was, such an inhabitant or parishioner.

### **PART 1 – Interment**

For interment in a grave. This includes digging of the grave when the interment is made between 10 a.m. and 4 p.m. on any day permitted by the Milton Keynes Council and includes the right to place one vase not exceeding 18 inches (0.40 metres) in height on the ground.
