This Notice is published in accordance with Regulation 16(1) of the Local Authorities (Members' Allowances) (England) Regulations 2003.

The Council, on 22 January 2020, agreed to re-adopt its scheme of Councillors' Allowances for the year 2020/21 and, in doing so, gave due regard to the recommendations made by the report of the Independent Panel on the Remuneration of Councillors 2018.

The scheme will apply from 1 April 2020, unless amended or revoked, until 31 March 2021.

**The Council's Scheme of Allowances 2020/21**

The Basic, Special Responsibility and Civic allowances payable to councillors have been increased by 2% compared to those paid in 2019/20 in accordance with the recommendations of the Independent Panel on the Remuneration of Councillors 2018. The Dependent Carer's Allowance, which is indexed linked to the minimum wage, has also been increased in line with the increase in the minimum wage. No other changes have been made to the scheme.

The main elements of the scheme are the payment of a Basic Allowance of £10,924 per annum to each of the 57 Members of the Council and the payment of Responsibility Allowances to certain councillors who have been appointed to particular offices by the Council:

Travel and subsistence will be paid at the rates agreed by the National Joint Council for the reimbursement of Council officers.

Special Responsibility Allowances are not cumulative. If more than one position attracting a Special Responsibility Allowance is held, only the highest applicable allowance will be paid.

In addition, £640 per annum is paid to the co-opted members on the Audit and Children and Young People Scrutiny.

#### **Allowance and Expenses Payments made in 2019/20**

The Council is required to make available the amounts paid to each councillor in respect of basic, Special Responsibility and Carer's Allowances for the previous year (2019/20).
