## **NOTICE OF CONFIRMATION OF A PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

### **TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND PARAGRAPH 1 OF SCHEDULE 14 AND WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53A(2)**

#### **THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (FOOTPATH 54 HANSLOPE (PART)) PUBLIC PATH DIVERSION ORDER 2021**

On the 23 September 2021, the Council of the Borough of Milton Keynes confirmed the above Order. The effect of the confirmed Order will be to divert part of Public Footpath 54 Hanslope from point A at OS Grid Reference SP 79986 47051 in a general north north-westerly direction for approximately 85 metres to point B at OS Grid Reference SP 79946 47127 at the junction with Hanslope Footpath 76. The width of this part of Footpath 54 Hanslope is 1.5 metres throughout as indicated by the points stated above and shown on the Order map by a bold black line.

The Order will then create an alternative footpath running from point A at OS Grid Reference SP 79986 47051 in a general west south-westerly direction for approximately 53 metres to point C at OS Grid Reference SP 79941 47022 at a junction of Hanslope Footpath 1 as indicated by the points stated above and shown on the Order map by bold black dashed lines. This confirmed footpath will have a length of approximately 53 metres and a width of 2 metres throughout.

This Order comes into effect on the date on which Milton Keynes Council certify that the terms of Article 2 of the Order have been complied with, but if any person aggrieved by the Order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, they may apply to the High Court for any of these purposes under section 287 of the Town and Country

Planning Act 1990 within 6 weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.
