7. How are people likely to be affected (positive and negative) by this decision? (Identify the range of options and the effects of each)

Transport and mobility are major issues for older people and people with disabilities. A plan that is sensitive to their needs is vital. The main considerations are:

Decisions about transport improvement schemes and transport system design (services) can impact all involved, however if their needs are not taken into account these decisions can have most impact on the elderly, those with disabilities and people in deprived/socio-economically disadvantaged groups.

Typical impacts range from:-

- an inability to gain physical access to transport when infrastructure does not take account of protected characteristic groups and/or
- unequal patterns or standards of service for protected characteristic groups which affect their lifestyle.

During the public consultation a number of equality groups responded to highlight concerns over how schemes would take into account accessibility needs, particularly of older and disabled people, and give consideration over how different genders use different transport modes and in different ways. The TIDP prioritised schemes will enhance accessibility and modal choice and overall support greater equality of opportunity. The extent to which they achieve this will depend on the next stages of their development and design. The EqIA and comments raised during the consultation will inform this further work on the schemes, as well as future work undertaken on the enabling policies which will be subject to their own EqIA's.
