In line with legislation, planning officers take the comments received into account when determining an application. In the preparation of planning policy documents, officers will, where possible, prepare responses for each comment received. However, it is common to receive a large volume of responses to some policy documents and it is not possible to respond to each comment individually. In these cases, comments will be summarised and responses to the issues raised prepared. Furthermore, as part of the adoption process for statutory planning documents, a Consultation Statement is prepared which sets out the engagement that has been undertaken at each stage of the process, the main issues raised to the consultation and the changes that have been made to the document as a consequence.

	Within Milton Keynes the Trust owns and manages the Grand Union Canal and we are a member of the Bedford Milton Keynes Waterway Trust seeking to promote the creation of a new waterway link between the two towns.		

The Canal is a valuable asset as it runs through the district. It represents our industrial and cultural heritage, shapes the landscape, adds ecological value, and has a great ability to act as catalyst for regeneration and inward investment as well as providing opportunities for sport and recreation, both on and off the water, thus enhancing the wellbeing of local residents.

## **Planning Applications**

Under the DMPO 2015 the Canal & River Trust are the statutory consultee (all rights were transferred from British Waterways in 2012) for development likely to affect any inland waterway (whether natural or artificial) or reservoir owned or managed by the canal & River Trust or any canal feeder channel, watercourse, let off or culvert which is within an area notified for the purposes of this provision to the local planning authority to the Trust.

The Trust should also be consulted where the grant of advertisement consent would affect the safety of persons using any waterway, dock or harbour for which the Trust is the navigation or harbour authority. This requirement is set out in the Town and Country Planning (Control of Advertisements) (England) Regulations (2007).

This means that the Trust should be consulted on applications in the vicinity of the canal in our role as statutory consultee as well as sometimes the adjacent land owner. Unfortunately, there have been issues with firstly over consulting and then not consulting the Trust at all which has led to us not being provided with the opportunity to comment on several applications which have an impact on the Trust. Hopefully this issue is now resolved following the re-provision of a link to our consultation buffer maps. Up to date consultation buffer details can be found here.

We have a statutory duty to respond to the consultations and pre-application consultations we receive as a statutory consultee and we must provide further evidence of the performance to government.

The link <u>here</u> may help to explain when to consult us.

The Canal & River Trust Planning Buffer will be applied to identify those developments that the Trust would need to be consulted on.

We encourage pre-application consultation from developers and local planning authorities - and we do not charge for this. The Trust would welcome the opportunity to work with you in respect of pre-application consultations for development within the Trusts defined notifiable area when development is likely to impact upon the Trust's assets. Applicants should be encouraged to consult us directly where appropriate, please see the relevant part of the Trusts website <a href="here">here</a>.

The Trust is not a statutory consultee on applications in the vicinity of the Bedford Milton Keynes Waterway, but in accordance with our charitable aims we will comment on applications which might have an impact on the delivery of the new waterway.

## Planning Policy

Whilst the Trust is a statutory consultee on certain types of planning, in order to meet the Trust's wider objectives it is also of vital importance for us to engage with the production of all levels of planning policy and associated documents to provide a robust policy framework that supports and recognises the canal as a cross cutting policy theme.

The Trust is keen to ensure that planning policy at all levels acknowledge and support the multi-functional roles of the canal network. Around 96% of land adjacent to the canal is outside of our control which can pose many challenges to the Trust, with development placing extra liabilities and burdens upon the waterway infrastructure, at the same time as providing opportunities for restoration and enhancement. Although the Council do tend to consult the Trust on planning policy we are not specifically mentioned in the document in relation to such consultations.

The Trust would welcome earlier engagement in the Neighbourhood Plan process and ask you to promote early engagement with us to the various neighbourhood forums in order that we are able to comment on their plans earlier in the process to avoid situations where we might need to object to
