

V1 Virtual Vaccination Permit

Guidance Notes:

Who can apply?

Starting from Monday 8 February 2021, any NHS staff working at the Saxon Court Vaccination Centre may apply for a permit to park for free in designated Council parking bays. You don't need to be a MK resident to apply*.

Where you can park

V1 permit holders will be able to park in the bays where the V1 permit sign is displayed. These 69 bays are located between South Eighth Street & South Row close to the vaccination centre.

About the V1 permit

The new V1 permit is free of charge and can be applied for weekly or monthly (maximum 3 months per application). The permit is valid for parking at any time (24-7).

This is a virtual permit so you will not receive a paper version to display in your vehicle, but your registration number and permit information is stored on our system.

Parking enforcement officers will check the registration number against the stored details so it's important you provide the correct registration number when applying.

How to apply

If you meet the criteria for a V1 permit you can apply online at www.milton-keynes.gov.uk/highways-and-transport-hub/parking/parking-permits-apply-here

First you will need to create an account if you haven't already got one.

*If you live in MK, you should register as a 'Resident' when applying. If you live outside MK, register as a 'Non-Resident'.

You will also need a Letter from the Site Manager and your NHS ID to apply.

Please note:

You may only use this permit to park in the locations listed above. You may be issued a Penalty Charge Notice (PCN) if you park elsewhere with this permit or on yellow lines, footways or verges or do not park within the bay markings.

It is an offence for a person to knowingly make a false statement for the purposes of obtaining a V1 permit (Vaccination Permit). A Permit may be withdrawn if obtained by fraudulent

means. MK Council will not hesitate to prosecute, and a conviction may result in a substantial penalty.

Vehicle Eligibility

A V1 permit Vaccination Permit may be used in the following types of vehicle;

- A passenger vehicle, which carries no more than 12 passengers.
- A goods vehicle weighing less than 3.5T gross laden weight.

Permits will not be valid for trailers. It is prohibited for any street trader vendor's vehicle to be parked or operate from any parking place.

Please note: Permits are not transferable for example, for use in courtesy or borrowed vehicles

Renewing your V1 permit

Your permit will not automatically be renewed so you must remember to do this. Renewal applications should be made at least 5 working days before your current permit expires.
