Graham,

We confirm receipt of the three documents and these will be addressed in the DCC update papers.

As you're aware, the holding response from Highways England is until 24th April 2020, which would be after the April 2nd DCC, so a deferral so based on the current circumstances would not be sufficient to address that point.

Due to elections there wouldn't be a DCC in May so a deferral could result in the case being determined at June DCC, the exact date of which is yet to be determined.

We would need to provide context to DCC members in relation to the consequences of deferring the application. Based on this, can you confirm an extension of time until the end of June 2020 would be acceptable so that we can confirm this to DCC members as part of an update?
