Thank you for providing us with AECOM TN's 11 and 12 on Monday 6th July.

On the back of your mitigation design comments in TN12 (associated with the superseded scheme supplementing the Eaton Leys scheme), we have produced the following set of drawings to support the latest A5 Kelly's Kitchen Roundabout mitigation proposals. These drawings supplement the VISSIM model files and results sent to you on 19th June and are as follows:

- SK02_S2_P3 – Proposed Kelly's Kitchen Roundabout Mitigation
- SK03_S2_P3 – Proposed Kelly's Kitchen Roundabout Mitigation Visibility Splays
- SK04_S2_P3 – Proposed Kelly's Kitchen Roundabout (HGV Swept Paths)

For completeness, I also attached TR_001 – Site Access Roundabout_S2_P12, which shows how the mitigation scheme ties in with the dualling and site access roundabout in Brickhill Street.

We look forward to receiving your response in relation to the VISSIM model and associated mitigation drawings.

We consider the attached mitigation scheme proposal does not warrant a WCHAR Assessment on the basis it does not impact pedestrian, cyclist or equestrian users, which is a reason for exemption listed in DMRB GG 142 at paragraph 1.2 (3). Assuming you agree with this, I will complete the exemption file note provided in Appendix A of GG 134 for our records.

Do you require a Stage 1 Road Safety Audit of the scheme proposals to be undertaken in advance of lifting your holding recommendation? If so, we will prepare the RSA Audit Brief for agreement with yourselves next week.
