Dear David,

Having spoken with Dr. Dawson, the document was prepared as an initial draft but never completed for the reasons set out at §4.65; and for that reason hasn't been produced to the inquiry. As explained in §4.65 it was superseded by the work that informed the SHA and was therefore never progressed further. It is emphatically not in a form which is fit for production, and the Appellant has never instructed the consultants to finalise the report therefore.

Were it to be finalised it would now have to take into account the subsequent work, in particular the SHA and the BWB report, which the Inspector has already ruled on. In the circumstances the Appellant is not minded to instruct the consultants to complete work on this draft document and produce it to the inquiry, but instead relies upon the SHA, the ES, the supplementary ES and the BWB report as to the consequences of preservation in situ.
