

School Grant Funding

PE & Sports Premium

The Department for Education (DfE) have confirmed on 25 June 2022 that the PE & Sports grant will continue. £320 million will be delivered to schools in 2022 and 2023 to give more children access to high quality PE lessons and sporting opportunities.

Allocations for the academic year 2021 to 2022 were calculated using the number of pupils in years 1 to 6, as recorded in the January 2021 census, as follows:

- schools with 17 or more pupils receive £16,000 plus £10 per pupil
- schools with 16 or fewer pupils receive £1,000 per pupil

Allocations were paid to schools in November 2021 and May 2022, we await further details of the allocations for 2022-23.

Universal Infant Free School Meals (UIFSM)

Provisional Allocation - For the academic year 2022 to 2023, a provisional allocation will be made to schools that is the total number of eligible meals taken in 2021 to 2022 multiplied by £2.41 x 190 days and by seven-twelfths.

Final Allocation - A final allocation for academic year 2022 to 2023 in June 2023 using the number of pupils recorded as taking a meal in year 1 and year 2 in the October 2022, and January 2023, school censuses. We then subtract those pupils known to be eligible for free school meals (FSM) in the same censuses who are taking a meal. This figure is then divided by 2 to give the average number of eligible UIFSM pupils in years 1 and 2.

The number of reception pupils used will be the greater of either:

- the number of pupils recorded as taking a meal in the October 2022 and January 2023 school censuses, minus those pupils taking a meal known to be eligible for FSM in the same censuses, divided by 2 (this gives the average number of eligible UIFSM pupils in reception for academic year 2022 to 2023) or
- the number of pupils recorded as taking a meal in January 2023 school censuses, minus those pupils taking a meal known to be eligible for FSM in the same census.

Payment Arrangements - The Secretary of State will pay the grant to local authorities as follows:

Month	Proportion of grant
June 2022	Seven twelfths of each school's provisional allocation. Schools that were academies on 1 May 2022 will receive their UIFSM grant direct from EFSA in July 2022.
June 2023	The final allocation for each maintained school as at 1 June 2023, minus the amount of the allocation paid in June 2022. Any school that converts to academy status after 1 June 2022, and by 1 June 2023, will receive the rest of its allocation direct from EFSA in July 2023.

Teachers Pay Grant & Teachers Pension Employers Contribution Grant

Maintained schools and academies with post 16 pupils and early years settings currently receive allocations for teachers' pay grant (TPG) and teachers' pension employer contribution grant (TPECG) from ESFA. These will initially be provided to these schools as separate grants outside of the national funding formula (NFF) in 2022/23, however the TPG post 16 element will then be rolled into the core 16-19 funding from the 2022/23 academic year.

Teachers Pay Grant (TPG)

From the 2021 to 2022 financial year, the majority of the funding to provide support to schools with respect to the 2018 and 2019 teachers' pay awards has been paid through the schools and high needs national funding formulae.

For the full 2022 to 2023 financial year, the DfE will provide maintained nursery schools and school nurseries with the teachers' pay grant, paid separately to core allocations.

They will pay eligible schools (sixth forms and 16-19 schools) the post-16 element of the teachers' pay grant for April to August 2022 as a separate grant. The teachers' pay grant will then be rolled into core 16-19 funding from the 2022 to 2023 academic year.

Teachers Pension Employers Contribution Grant (TPECG)

TPECG provides funding for schools to support the increase in the employer contribution to the teachers' pension scheme that came into effect on 1 September 2019.

From 1 April 2021 the majority of this funding has been paid through the schools, high needs and central school services block national funding formulae (NFF). Maintained nursery schools, school nurseries, sixth forms and 16 to 19 schools are not funded through the NFF. In the financial year beginning 1 April 2022 these institutions will continue to receive the TPECG, paid separately to core allocations.

The grant covering the 2022 to 2023 financial year is paid in 2 instalments, the first of which is paid in April and covers April 2022 to August 2022. The second payment covers September 2022 to March 2023.

Pupil Premium

Pupil premium is funding to improve education outcomes for disadvantaged pupils in schools in England. Evidence shows that disadvantaged children generally face additional challenges in reaching their potential at school and often do not perform as well as other pupils.

Service pupil premium is additional funding for schools, but it is not based on disadvantage. It has been combined into pupil premium payments to make it easier for schools to manage their spending.

Schools get £320 in 2022 to 2023 for every eligible pupil.

For mainstream and special schools, the pupil premium for 2022 to 2023 will include pupils recorded in the October 2021 school census who have had a recorded period of FSM eligibility since January 2016, as well as those first recorded as eligible in October 2021.

For pupil referral units, the pupil premium for 2022 to 2023 will include pupils recorded in the January 2022 school census who have had a recorded period of FSM eligibility since May 2016, as well as those first recorded as eligible in January 2022.

Recovery Premium

The recovery premium grant is part of the government's package of funding to support pupils whose education has been impacted by coronavirus.

This is a time-limited grant providing additional funding for state-funded schools in the 2021/22, 2022/23 and 2023/24 academic years. It is focused on pupil premium eligible pupils and pupils in specialist settings such as special schools, special units and pupil referral units (PRUs).

Funding rates for 2021/22 and indicative rates for 2022/23 academic years are: -

Payments will be sent to local authorities to pass to schools in 4 instalments for the academic year 2022-23: -

30 September 2022, 30 December 2022, 31 March 2023 & 30 June 2023.

Supplementary Grant

Funding has been allocated to mainstream schools and academies to provide support for the costs of the Health and Social Care Levy and wider costs.

Payments will be made in June 2022 to cover April 2022 to August 2022, and in November 2022 to cover September 2022 to March 2023. This additional funding will be provided in each year of the current spending review period.

The payment of this additional funding in the form of a separate grant will be for 2022/23 only. The funding will be incorporated into core budget allocations for 2023/24 where possible. So, for primary, secondary and all-through schools, this will mean the funding being rolled into the schools national funding formula (NFF) for 2023 to 2024.

School-led Tutoring Grant

As part of the DfE's education recovery plan, the Secretary of State for Education is providing financial assistance to eligible local authorities, for their maintained schools, and academy trusts.

All state-funded primary, middle and secondary schools and academy trusts in England with pupils in years 1 to 11 who are eligible for pupil premium will receive a school-led tutoring grant.

In their September and December 2021 payments, state-funded schools and academy trusts in England received £202.50 per pupil for 60% of their pupils that are eligible for pupil premium, from year 1 to year 11.

From May 2022 until the end of the academic year, funding allocations will be increased by 16 percentage points from 60% to around 76% of pupils that are eligible for pupil premium in years 1 to 11.

In recognition of higher costs, non-mainstream education providers receive £529 per pupil for 60% of pupil premium pupils. From May 2022 the allocations for these education providers will also increase by 16 percentage points from 60% to around 76% of pupils eligible for pupil premium in years 1 to 11.
