PUBLIC NOTICE

MILTON KEYNES CITY COUNCIL (VARIOUS ROADS, BLETCHLEY) (PROHIBITION AND RESTRICTON OF WAITING) EXPERIMENTAL ORDER 2022

NOTICE IS HEREBY GIVEN that the Council of the Borough of Milton Keynes has on **18 October 2022** made the above Experimental Traffic Order under Sections 9 and 10(2) of the Road Traffic Regulation Act 1984 for the purposes of carrying out an experimental scheme of parking control for a period of **18 months**.

The general effect of the experimental Order will be to introduce the following no waiting restrictions along parts of Drayton Road, Manor Road, Mill Road, Phelps Road, Stoke Road, Water Eaton Road and Windermere Drive in Bletchley:

- To introduce no waiting at any time along parts of Drayton Road, Manor Road, Mill Road, Phelps Road, Stoke Road, Water Eaton Road and Windermere Drive.
- To introduce no waiting between the hours of 8.00am & 6.00pm along parts of Stoke Road.

As the Highway Authority for the above lengths of road, Milton Keynes City Council is satisfied that the introduction of the above experimental restrictions will help to alleviate obstruction and encourage a safer environment for pedestrians and cyclists.

The Experimental Order will come into effect on **01 November 2022** for a period of 18-months.

The Council will continue to monitor the way in which highway facilities are used and address any issues that come to its notice and following meaningful consultation with all stakeholders do what it considers necessary to facilitate the expeditious, convenient and safe movement of vehicular and pedestrian traffic.

A copy of the Experimental Order as made including maps indicating the locations and their effects, together with a statement of the Council's reasons for making the Experimental Order, may be inspected on the Council's website at: www.milton-keynes.gov.uk/consultations.

The Council will be considering in due course whether the provisions of the Experimental Order should be continued in force indefinitely. Any person wishing to object to the making of the Experimental Order for the purpose of such indefinite continuation should put their objection in writing stating the title of the relevant Order, and the grounds on which the objection is made, and send to the Council's Traffic Regulation Order Team at Milton Keynes City Council, Civic Offices, 1 Saxon Gate East, Central Milton Keynes, MK9 3EJ, or by email to TROteam@milton-keynes.gov.uk quoting reference ETRO-024, to be received within a period of 6 months beginning with the day on which the Experimental Order comes into operation, i.e. to be received by the Council no later than 30 April 2023.
