1. Opening matters

2.2 Shared prosperity Fund

ZA: The UK Shared Prosperity Fund (SPF) is a central pillar of the UK government's ambitious Levelling Up agenda and a significant component of its support for places across the UK. It provides funding for local investment by March 2025, with all areas of the UK receiving an allocation from the Fund through a funding formula rather than a competition.

MKCC allocation is for 3 years which will be shared across the three investment priority groups:

- Place & Community
- Business & Innovation
- Skills & People

MKCC has only received the grant and there is funding available under the following themes:

- Investment in community engagement schemes for decision making in local regeneration
- Capacity building for local civil society and community groups

Under these themes MKCC can potentially offer support and funding to ERFs. The ERFs will need to apply for the grants and if successful deliver the initiatives locally.

2.6 Update Regeneration/renewal

ZA gave an update on Social Housing Decarbonisation Fund (SHDF)

- An application of Social Housing Decarbonisation Fund (SHDF) Round 2 was made on the 18th November 2022.
- The application included the following improvements to Council homes on Fullers Slade:
 - over cladding,
 - replacement windows and doors,
 - roof insulation to existing properties.
- The proposals are similar to those for Netherfield, which received grant funding from SHDF Round 1
- the changes will ensure that residents heating bills are reduced by these improvements.
- The published timetable for the evaluation of bids and notification of successful projects in Round 2, is to be by late February/ Early March 2023

Discussion about help for homeowners – Although SHDF is for council stock there is support and advice available from Wolverton Community Energy who can advise on grants to improve insulation and make them more energy efficient.

Regarding the new development, the ERF wants an update on what's happening and when.

HH- would like an open meeting to update residents.

Group agreed that ERF will have an open meeting to announce the latest decision on the development and the outcome of the SHDF grant application.
