3a. Fly-tipping Update

SH Thanked Crawford for the work he has been doing on the estate. 2019 MKCC developed a fly-tipping action plan to reduce fly-tipping across Milton Keynes. Is a need for residents to report people fly-tipping. Is a need for information from residents, helps MKCC to fine offenders.

'Kangaroo trucks' are not financially sustainable and doesn't really solve problem . Discussion was opened up to the group.

Questions about reporting fly-tipping, Keep Britain Tidy (KBT) and non-Lakes Estates residents fly-tipping

SH reminded group the MKCC would not share information of residents unless it goes to court. If people want to report fly-tipping: scu.enforcement@milton-keynes.gov.uk can use the email to send photos etc. Using CCTV does stop fly tipping in one area, but it moves to other areas. MKCC have worked with KBT in the past.

4. Regeneration update

RM Graham group has been selected. This is in 2 stages:

- Pre contract service agreement
- BUILD

Graham are developing a stakeholder engagement strategy. There will be more ground investigation over the next 2 weeks.

MKCC are pushing Graham for a time line. Target is to be on site in 2023.

Stage 2 will have to be approved by Cabinet.

Nursery in phase A will be moved to phase B as it still needs to be acquired.

Community Hub: no decision on management currently.
