**1.1** DM welcomed group, apologies from Cllr Wilson, Steve Summerfield and Donna Addington. Group held a hybrid meeting with NK joining on Teams. Group agreed minutes of last meeting were accurate.

#### **1.2** DM introduced NK from neighbourhood watch (NW).

NK spoke to group about the history of NW, and how NW works including:

- Giving alerts to police via a website
- Discounts available on home insurance

Future Projects: Sub-group looking to apply for funding for events over Halloween and Christmas including a Christmas party and trip.

#### 1.6 Hub update

Hub will reopen on 18 September. Community Engagement team will be using this as an office and to hold community sessions including Brunch Club. Youth team will be using the Hub to hold some youth sessions, Housing officer plans to hold a drop-in session once a month.

Discussion about a re-opening event for the Hub. Group discussed an exhibition, music, workshops and food.

Group discussed the need for an AGM at this present time. Group agreed before they set a date for an AGM they need the letter from Cllr Darlington on regeneration in the area.

ZA has emailed Cllr Darlington numerous times about this letter and has sent her a draft copy to speed up the process.
