(VARIOUS ROADS, ROOKSLEY) (CONSOLIDATION OF WAITING
RESTRICTIONS AND PROHIBITION OF RIGHT TURN) ORDER 2017)
VARIATION ORDER 2023

Milton Keynes City Council (“the Council”) in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the day of 2023 and may be cited as “Milton Keynes City Council (The Council of the Borough of Milton Keynes) (Various Roads, Rooksley) (Consolidation of Waiting Restrictions and Prohibition of Right Turn) Order 2017) Variation Order 2023”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Rooksley) (Consolidation of Waiting Restrictions and Prohibition of Right Turn) Order 2017 and form part of that Order.
5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereunto are hereby revoked or varied to the extent stated in that Part.

PART 2

VARIATIONS

6. The Council of the Borough of Milton Keynes (Various Roads, Rooksley) (Consolidation of Waiting Restrictions and Prohibition of Right Turn) Order 2017 (“The Principal Order”) is varied as provided by the following provisions of this Order: -
7. Item NW22 in Schedule 1 of the Principal Order is revoked and replaced by the following: -

PATRIOT DRIVE, ROOKSLEY
SOUTH-EAST SIDE

NW22 From its junction with the south-western kerbline of Grafton Street (V6), for a distance of 226.5 metres, in a south-westerly then south-easterly direction.

REVOCATIONS

8. The following Order is hereby revoked to the extent stated below:

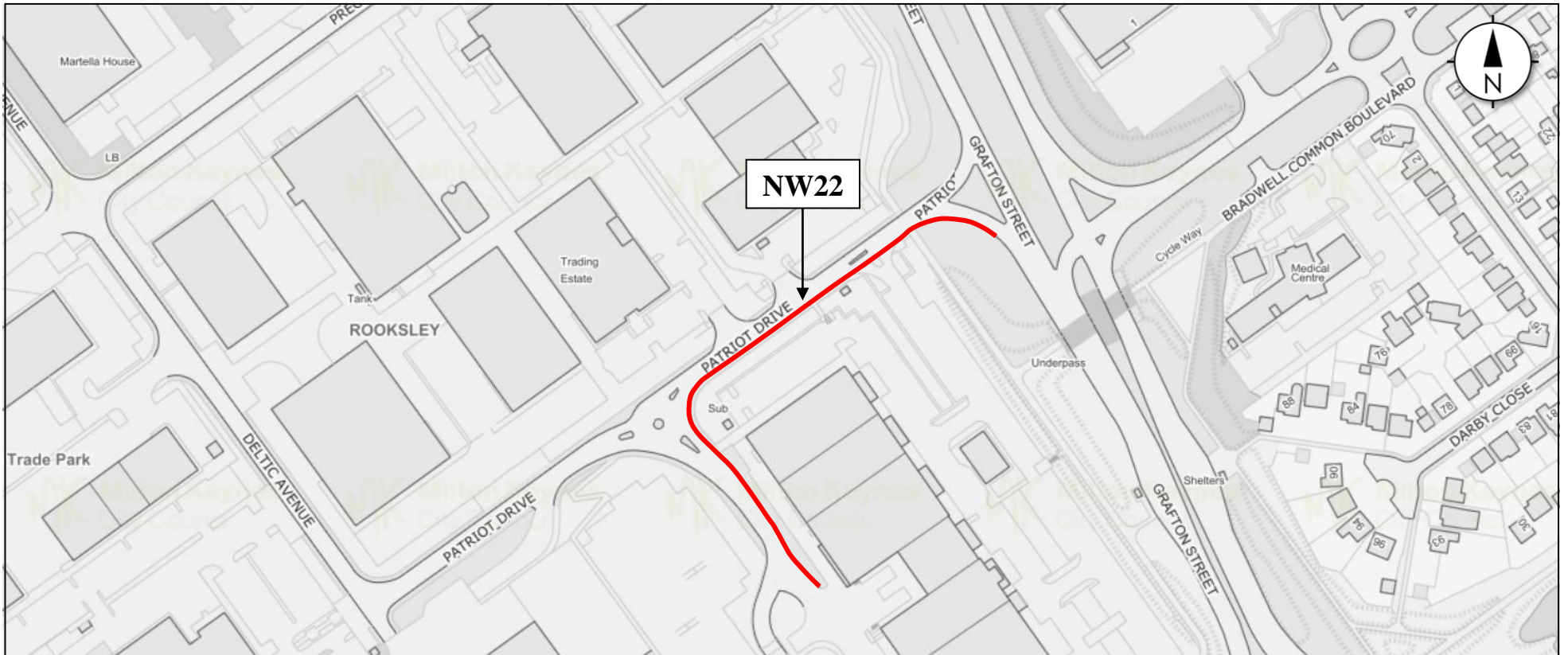
