# Key dates for your diary

#### **Repairs and Maintenance on Serpentine Court**

Queries have been raised regarding repairs/maintenance in the area. MKCC continues to do repairs and maintenance work at Serpentine Court. This includes maintaining the additional external lighting and lifts. So please continue to report any communal issues in the usual way.

Where parts of individual properties are beyond repair, MKCC will replace or upgrade as needed, these are being done on a case-by-case basis. MKCC continue to do safety checks on areas such as fire doors and emergency lighting. MKCC have recently fenced off parts of the estate due to repairs or the need to section off areas that are out of use. Alternative routes are in place.

There is also signage up at the back of the shops to remind people not to go onto the roofs. The roofs are only designed to take the load of the roof, not people. If you see any people on the flat roof, please report it to Thames Valley Police and your neighbourhood officer. This is because they are putting themselves at risk, as well as breaking the law.

MKCC is in touch with Thames Valley Police and Buckinghamshire Fire and Rescue to ensure that where other agency support or updates are needed, this is actioned. Over the coming weeks you will see colleagues from Buckinghamshire Fire and Rescue carrying out inspections of the area, please note this is part of the routine maintenance checks for the area.

For individual properties, Neighbourhood Officers have been contacting every tenant to check in on them and their property, this started in early October. If you haven't had a visit yet you can contact your housing team on the number below to arrange a visit at a time/date that suits you.
