(Lavendon Footpath 5 (Part))
Public Path Diversion Order 2024**

This Order is made by the Council of the City of Milton Keynes ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order and the public, it is expedient that the line of the footpath should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Milton Keynes Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

The applicant has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Lavendon Parish Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Lavendon and shown by a bold black continuous line on the plan contained in this Order ("the Order Plan") and described in Part 1 of the Schedule to this Order ("the Schedule") shall be stopped up after 28 days from the date of confirmation of this Order and thereupon the Milton Keynes Definitive Map shall be modified by deleting from it that public right of way.
2. Notwithstanding this Order, where immediately before the date on which the footpath is diverted, there is apparatus under, in, on, over, along or across the paths belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of their apparatus as they then had.
3. There shall be at the end of 28 days from the date of confirmation of this Order a public footpath over the land situate at Lavendon described in Part 2 of the Schedule and shown by a bold black broken line on the Order Plan and thereupon the Milton Keynes Definitive Map shall be modified by adding that path to it.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule to this Order.

5. The Milton Keynes Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order

SCHEDULE

PART 1 DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The current route travels from point A at O.S Grid Reference 490236 256092 in a south-westerly direction for approximately 12 metres to point B at O.S Grid Reference 490226 256083, then continues in a general south-south-easterly direction for approximately 45 metres to point C at O.S Grid Reference 490236 256039.

The current length is 57 metres travelling around the eastern perimeter of the Northey farm site.

PART 2 DESCRIPTION OF SITE OF NEW PATH OR WAY

The new route will run from point A at O.S Grid Reference 490236 256092 in a southerly direction for approximately 53 metres to point C at O.S Grid reference 490236 256039

The length of the route will be 53 metres and will have a width of 1.8 metres.

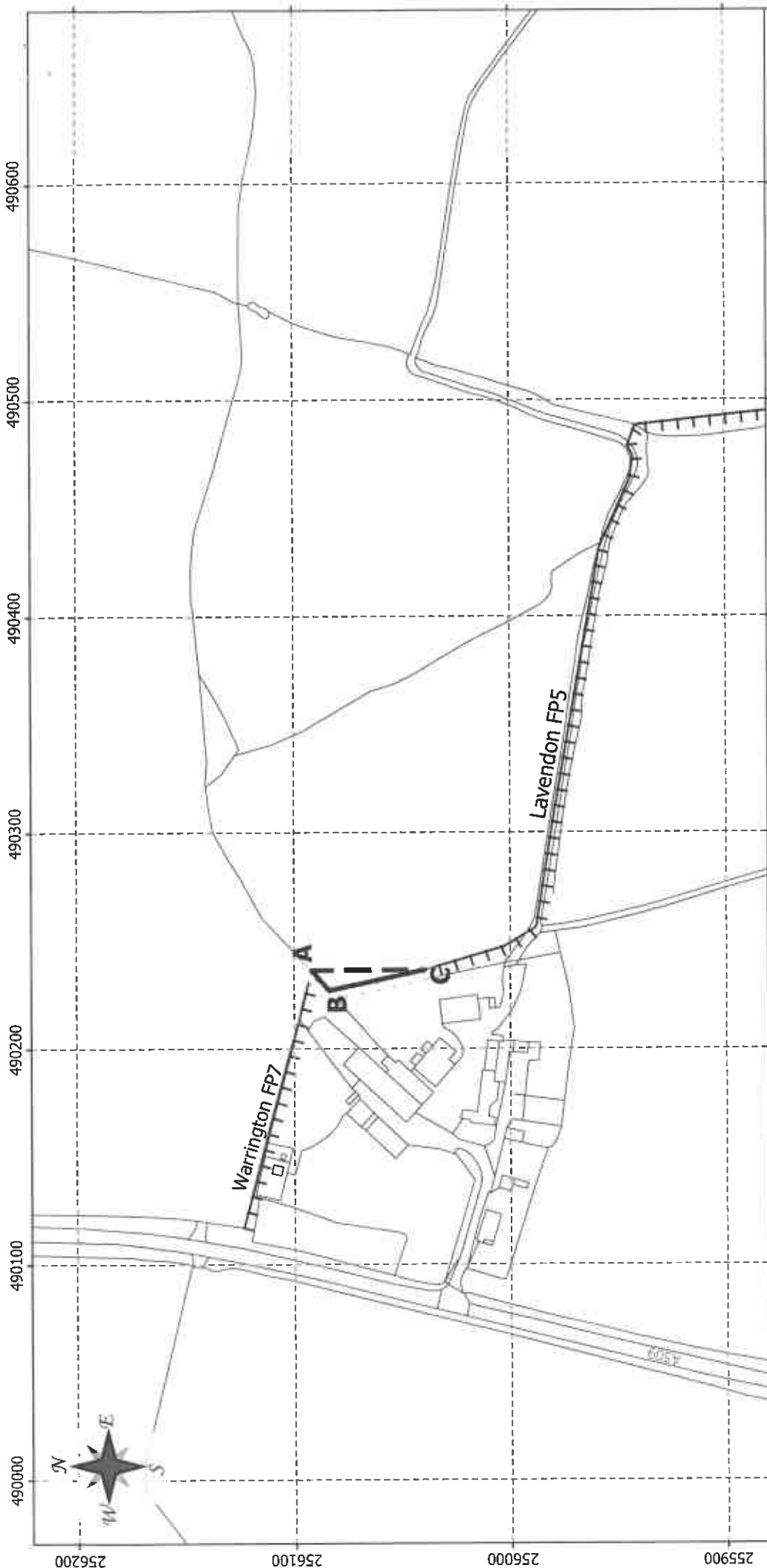
