It stands to reason that if traffic flow problems exist towards Monkston roundabout then it wouldn't be a dangerous right turn from Claridge Drive as the cars would be queueing which they are not. If you remember that is why traffic calming measures were introduced down thy H7 to slow cars down which has not helped slow them all so clearly traffic flow is fine. There have been several fatalities at the junction of Claridge Drive/H7. If the roundabout beyond Monkston towards Broughton was widened to allow 2 lanes of traffic to flow from the likes of the Kingston Centre and Costco then this would help so those turning right on the H7 aren't behind those turning left onto the H7.
