



Notice of landowner deposit under section 31(6) of the Highways Act 1980 and section 15A(1) of the Commons Act 2006

Milton Keynes City Council ('the Authority')

An application to deposit a map and statement and subsequently lodge a declaration under section 31(6) of the Highways Act 1980 and to deposit a statement under section 15A(1) of the Commons Act 2006 has been made in relation to the land (or lands) described below and shown edged in red on the accompanying map.

Parcel C is approximately 5.32 ha and is located at OS grid reference SP835434.
