OF WAITING) ORDER 2014) VARIATION ORDER 2025

Milton Keynes City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on the day of 2025 and may be cited as "Milton Keynes City Council (The Council of the Borough of Milton Keynes) (Featherstone Road and Blackhill Drive (Parts), Wolverton Mill) (Prohibition and Restriction of Waiting) Order 2014) Variation Order 2025".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

PART 2

VARIATIONS

3. The Council of the Borough of Milton Keynes (Featherstone Road and Blackhill Drive (Parts), Wolverton Mill) (Prohibition and Restriction of Waiting) Order 2014 ("The Principal Order") is varied as provided by the following provisions of this Order:-
4. The following items in schedule 1 of the Principal Order ARE HEREBY REVOKED IN THEIR ENTIRETY

NW19, NW20 and NW23

5. Item **NW21** in Schedule 1 of the Principal Order is replaced by the following:

BLACKHILL DRIVE, WOLVERTON MILL
SOUTH-WEST SIDE

NW21 From a point 132.4 metres north-west of a point in line with the northern kerbline of Featherstone Road, for a distance of 47.6 metres in a north-westerly direction.

6. Item **NW22** in Schedule 1 of the Principal Order is replaced by the following:

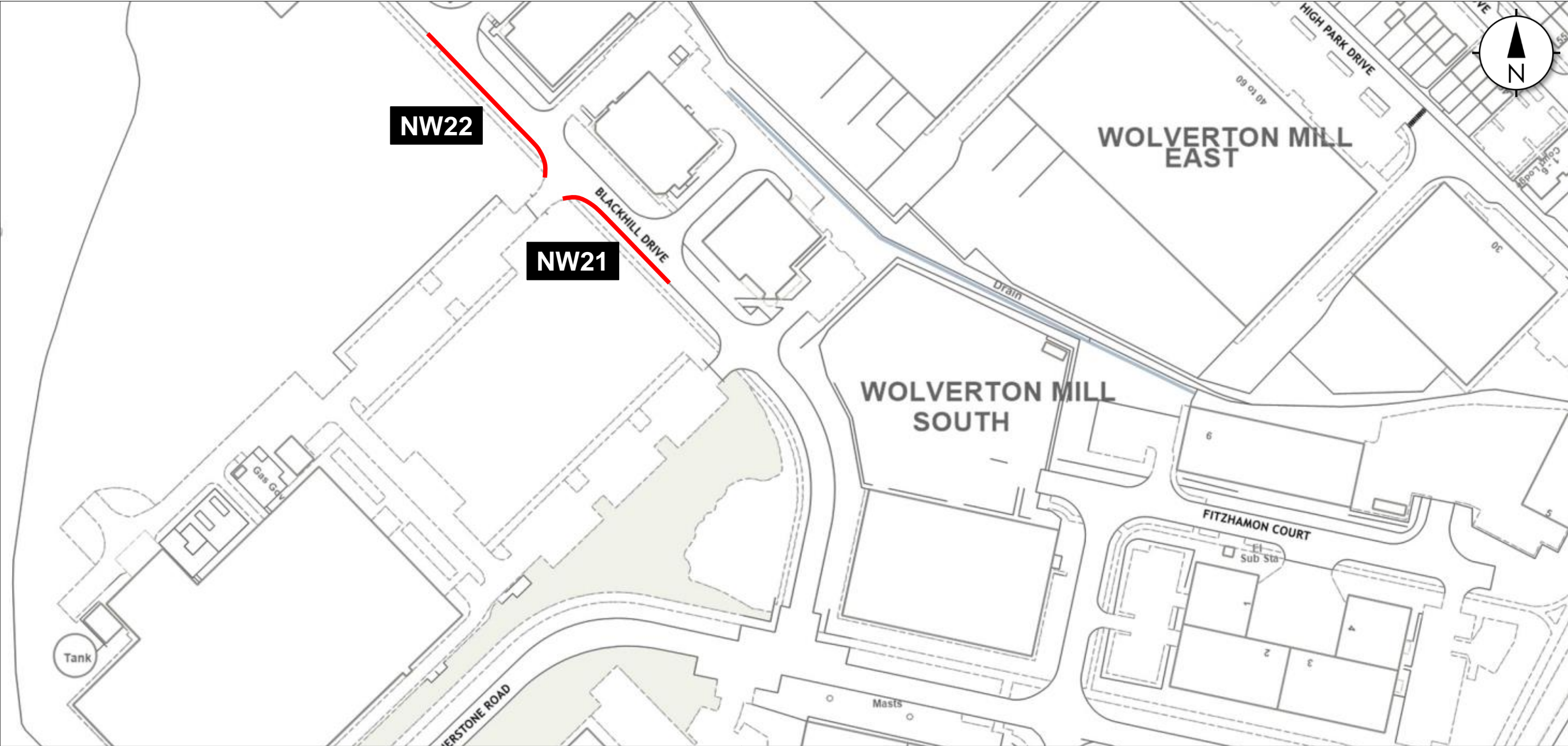
BLACKHILL DRIVE, WOLVERTON
SOUTH-WEST

NW22 From a point 221.6 metres north-west of a point in line with the northern kerbline of Featherstone Road, for a distance of 50 metres in a South-easterly direction.
