

# Applying for a secondary school place.

A guide for parents and carers

Apply between 2 September and 31 October 2025 to start secondary school in September 2026

www.milton-keynes.gov.uk/schooladmissions



### Apply on time

- The closing date is 31 October 2025
- Any applications received after this date will be processed in the second round after the majority of places have been allocated
- A late application therefore means you are much less likely to get what you want
- Notifications of the places offered will be made on 2 March 2026 (unless your application is late)

### **Apply online**

- You can apply online at www.miltonkeynes.gov.uk/schooladmissions up until midnight on 31 October 2025
- You will be able to view, update, submit / resubmit and check the status of your application throughout the process
- Notification of the place allocated will be quicker and your application will be secure
- You will be able to log on 2 March
   2026 to view the school that has been allocated

### Use all four preferences

- You could disadvantage yourself if you don't use your opportunity to express a preference for four schools
- Each preference is considered in its own right, so give yourself four separate chances, the schools do not know the order you have put the preferences
- If more than one school is able to offer your child a place the order of preference is important, so, ensure you list the school in the order that you want them considered.

### **Choose wisely**

- Understand the school's oversubscription criteria
- Improve your understanding of your chance of success by looking at the point when schools turned down applications last year
- Don't assume you will be allocated a place at your catchment school if you don't state it as one of your preferences
- Don't assume your child will get priority just because they attend a primary school within the area of the secondary school
- Consider how you will access your school place. Maximise your chance of getting a preferred secondary school place

# Section A General Information

### Applying for a secondary school place

There are two ways to apply for a secondary school:

- 1. Normal Entry: For children starting Year 7 in September (after turning 11).
- 2. In-Year Application: For children changing schools at any other time between Year 7 and Year 11.

# Secondary school admissions – starting in September 2026

This guide explains how to apply for children starting secondary school in Year 7.

If your child was born between **1 September 2014** and **31 August 2015**, it's time to start thinking about secondary school. They'll begin Year 7 in **September 2026**.

### Important date: National Offer Day

All offers will be sent out on 2 March 2026, so families across the country hear back on the same day.

### How it works

Milton Keynes City Council co-ordinates admissions for all local schools and those outside the area. The City Council work closely with other councils and schools to make sure every child receives ONE school offer, based on the highest preference possible from your application.

### Here's what to expect:

### Applying for secondary school – Milton Keynes residents

Milton Keynes City Council co-ordinates all secondary school applications for children living in Milton Keynes. If your child is starting secondary school in **September 2026**, you will send your application to the council—even if the schools you're choosing are outside of Milton Keynes.

# How to apply for secondary school

There are two ways to apply for a school place:

- 1. Online application: Most parents use the online system. The council provides a clear timetable to make sure everyone gets their school offer on the same day—National Offer Day (2 March 2026).
- 2. Paper application: If you prefer, you can ask the council for a paper form instead.

### If you live outside Milton Keynes

Apply through your local council who you pay council tax to, even if you want a school in Milton Keynes.

- After applications close, your council will talk to the Milton Keynes team to check for available places
- your application will be considered using the same admissions rules as everyone else.

# Visiting secondary schools

Each autumn, secondary schools hold open days and evenings for parents whose children will be starting year 7 in the following September.

### Find dates and times

- Check the listings for each school to see when their events are happening.
- Keep in mind—these dates may change, so always confirm directly with the school before attending.

### Why it's important to visit

- Visit the school for your catchment area and any other schools you're considering.
- Even if you already have a child at the school, don't assume things are the same—schools can change year
  on year.

# Child's home address requirements

To apply for a school place, the council requires that:

- Your child's home address is where they normally live—not somewhere they stay occasionally.
- The property must be owned, rented, or leased by the child's parent or legal guardian.
- If the child lives elsewhere under legal care (e.g. foster care), evidence must be provided.

### What the council would not normally accept

- Families claiming two main residences (we would check which is the main residence).
- Only part of the family moving—unless it's due to divorce or permanent separation, evidence will be required.
- Children living apart from parents/carers—unless it's a verified fostering arrangement.
- Overcrowded living arrangements with no formal record (e.g. two families in one unsuitable in size property).

### Verification and checks

- If there's doubt, the council will request proof of residence.
- We may check details with other agencies.
- If a school place was offered based on false or misleading information, (for example, a false claim to living in a catchment area) and this denied a place to another child, the offer of that place will be withdrawn by the admission authority for the school. This has happened in previous years.

# Planning to move house?

If you're moving home, here's what you need to know:

- You'll need to give the new address as part of your child's school application. Please update this on the application and keep the Access to Education team informed of the progress of your house move.
- Moving before the closing date? You can update your address and change your school choices before the
  deadline. You must provide proof by 31 October 2025 that you'll be living at the new address by
  1 September 2026.
- Moving outside Milton Keynes? Your application will be passed to the council where you'll be living. You
  still need to give proof of your new address, and the new local authority will take over ownership of the
  application and any further correspondence should be directed to them.
- What counts as proof of your new address?
  - ☐ The council requires confirmation that your house move is legally binding. A solicitor's letter confirming you've exchanged contracts on a purchased property and the move-in date.
  - Or, a signed by all parties rental agreement from an approved letting agency, showing you'll live at the new address on **1 September 2026.**
  - ☐ If you're building a house, you'll need legal documents showing when it will be completed and when you'll be resident in the property.

The council might ask for more proof if there's any doubt about your move.

### Moving after the closing date?

You'll need to fill out a new 'late application' form and send proof of your new address. This application
must be accompanied by documentary evidence of your new address (e.g. a copy of a signed lease/
rental agreement (extending over 1 September 2026) or copy of a solicitor's letter confirming exchange of
contracts/completion date). We will use your new address for correspondence purposes. The application
will be looked at in later rounds of school place allocations.

### **Proof of address**

To confirm your address, please include your council tax number in the application. This helps verify your details quickly.

If your name isn't on the council tax register, you'll need to email proof of where you live to **secondaryadmissions@milton-keynes.gov.uk**.

### What can you send?

- A council tax bill/number. You must be showing as the council tax bill payer or a named occupant at the property.
- A signed by all parties' tenancy agreement
- (In Year applications only) If you live with family or friends: a letter from them with their council tax number and proof that your name is listed as a named occupant
- A letter from the solicitor showing exchange of contracts (if you're buying a house)

If there is any doubt about the validity of this proof, or notification received indicating a different home address, further evidence will be requested. Other agencies may provide evidence that challenges the proof provided and lead to further investigation. In situations where an application is considered to contain any false or deliberately misleading information the application will be withdrawn and a fresh application will need to be made and processed as a late application in **April 2026.** 

# Joint residence arrangements

If you and your child's other parent live at separate addresses but share responsibility for your child:

- The council will require a written statement from both parents explaining how your child splits time between the two homes.
- If your child lives equally at both addresses, you must both choose and agree on one address to use for the school application.
- If there's disagreement, or your child spends more time at one home, we may ask for official proof of their main home—such as the address of the parent who receives child benefit.
- If there's a court order about where your child lives, that will take priority over any written agreement between parents.

# Choosing schools for your child

### When applying for school places in Milton Keynes:

You can list up to four schools on your application, in order of preference.

There's no guaranteed place at any school, even if you list it—places are offered based on a school's oversubscription criteria, not just your choice.

#### How it works

- We use the Equal Preference Scheme. It treats each school you've listed as a separate application.
- If there's space at your highest preference school, and you have applied for this school, your child will get a place.
- If that school is full, we look at your next preferences.
- If none of your choices can offer a place, your child will be placed at the next nearest school with space available. This may not be your catchment school, if you have not selected this school as a preference on the application.

### Tips to help you choose

- Some schools are full every year, so think carefully about which ones you select.
- Include your catchment school as one of your choices—it increases your chances of getting a nearby school place.
- Think about how your child will get to and from school. The council doesn't provide transport unless you meet the criteria in the School Travel Support Policy.

### **Applying from outside Milton Keynes**

If you live outside Milton Keynes and want your child to attend a secondary school here:

- Your child going to a junior or primary school in Milton Keynes doesn't automatically mean they'll get a place at a Milton Keynes secondary school.
- You'll need to get an application form from your local council (the one you pay council tax to).
- Your local council will work with Milton Keynes Council to check what places are available.

### A few things to keep in mind:

- If you're planning to move to Milton Keynes before the application deadline, you should fill in the Milton Keynes form and include a letter with details about your move.
- For more help with moving, check out the "Planning to Move House" section in the booklet.

### Where to find school information

• Visit school websites for details like inspection reports, achievement tables, uniforms, and open days. You can also check Ofsted's website for inspection results. www.reports.ofsted.gov.uk

### Important reminders

- Each preference is treated fairly—you won't lose out by listing more than one school.
- Schools don't see the order in which you've ranked your preferences.
- Each school has its own rules for how places are given (called oversubscription criteria). We have provided
  you with a snapshot of how places were allocated last year. However, this information is historical and will
  not necessarily reflect what will happen this year.
- Check Section E for summaries or visit each school's website.
- If your child is offered a place at your preferred school which is outside of your catchment area, then you should be aware that it may not be possible in future years to offer places to younger siblings.

# **Applying to schools outside Milton Keynes**

If you live in Milton Keynes and pay council tax to Milton Keynes City Council, but want to apply for a school outside the area (e.g. grammar schools in Buckinghamshire), here's what to do:

### **Application process**

- You must still complete a Milton Keynes school application—even if the school is in another local authority.
- This ensures your application is coordinated properly and considered alongside others.

### Research before you apply

Contact the local authority of the school you're applying to (e.g. Buckinghamshire Council) and request their admissions information.

### This helps you understand:

- Oversubscription criteria
- Catchment areas
- Transport policies
- Any additional documentation required

# Applying to a Buckinghamshire grammar school (for Milton Keynes residents)

If you live in Milton Keynes and want your child to go to a grammar school in Buckinghamshire:

- You must apply through the Milton Keynes City Council school application process.
- It's a good idea to use one of your school choices to select your catchment school, since grammar school places are not guaranteed.
- Even if your child qualifies, a place is not guaranteed each grammar school has its own admissions criteria for who is allocated, so check those details carefully.

### Important to know:

- If your child gets free school meals, tick that box in your application it might help your child's chances at some schools.
- If your child is offered a place at a Buckinghamshire grammar school, you'll need to arrange and pay for transport. Milton Keynes City Council does not offer transport to these schools, so speak to Buckinghamshire County Council about your options before applying.
- Make sure to include at least one Milton Keynes school on your list. If your grammar school application
  isn't successful, your child will be given a place at a school in Milton Keynes where there's space this
  might not be your catchment school if you didn't list it.
- Further information can be found at www.buckinghamshire.gov.uk

# **Siblings**

Including sibling details in your application can make a real difference—many schools give priority to children with siblings already attending.

For admissions, a sibling is:

- A brother or sister by whole or half blood
- An adopted child
- Any child who permanently lives at the same address and for whom the parent has parental responsibility

Always include sibling details in your application—it's your responsibility.

Sibling information is verified with the school, so accuracy matters. You must indicate where siblings have a different family name.

### **Check Each School's Criteria**

• Not all schools treat sibling priority the same—review each school's admissions criteria carefully.

# **Multiple Births**

If you're applying for school places and have twins, triplets, or other multiples, here's how Milton Keynes City Council will consider the children:

• If there's only one place left at a school and the next child on the waiting list is part of a multiple birth group (e.g. twins or triplets): All siblings will be admitted, even if this means going over the school's official admission number.

### Why this matters

This policy ensures that siblings aren't separated during school admissions. It applies to all year groups, not just Reception or Year 7

### Looked after children

These are children currently:

- In the care of a local council, or
- Living in accommodation provided by the council's social services at the time the school application is made.

### **Previously looked after**

These are children who were in care but have since:

- Been adopted, or
- Have a child arrangements order or special guardianship order. This also includes children who appear (to the admissions authority) to have been in state care outside of England.

If this applies to your child, make sure you tick the correct box or include these details in your application, so they can be prioritised

# School admissions for children with Special Educational Needs (SEN)

All children deserve equal access to education — and that includes those with special educational needs. Children with SEN are treated just like any other applicant when it comes to school admissions.

### No refusal based on needs

Schools cannot refuse a place simply by saying they aren't able to meet your child's needs. The local council will look at every application fairly, using the same over-subscription criteria as for any other child.

Make sure to share details about your child's needs in the application, so they can be properly supported from the start.

# School admissions for children with an Education, Health and Care Plan (EHCP)

If your child has an EHCP that names a particular school, here's what you need to know:

- Under Section 324 of the Education Act 1996, any child with an EHCP naming a school must be admitted to that school. This applies even if the school is full. It's not affected by oversubscription criteria
- If your child arrives outside the normal application period, the school still must admit them, as long as the EHCP names that school.

# Special provision in secondary schools for children with learning needs

Every secondary school is set up to help support children who have specific or moderate learning difficulties — including those with an Education, Health and Care Plan (EHCP).

If your child:

- Already has an EHCP, or
- Is currently being assessed for one

You're encouraged to speak with the school's Special Educational Needs Coordinator (SENCo). They will explain the support the school provides, and help make sure your child's individual needs are met.

### **Free School Meals**

If your child can get free school meals, please make sure to mention this on your school application—especially if you're applying to a grammar school in Buckinghamshire. Some schools may give priority to children who qualify, so it's important to include this information.

# School admissions for children of UK service personnel

If you're in the armed forces or a Crown servant returning from overseas, here's how school admissions in Milton Keynes will support your family:

### What the admission authority will do:

- Consider your child's needs, as outlined in the school's over-subscription criteria (for Community and Voluntary Controlled schools)
- Offer a place before you arrive if you provide an official letter (e.g. from MOD, FCO, or GCHQ)
  confirming your posting
- Prioritise based on service premium if you provide evidence your child receives it
- Accept alternative addresses such as a unit postal address or nearest 'quartering area' address, even if
  you don't yet have a new home

### **In-year admissions:**

- School places must be taken up by the beginning of the next term
- The council won't hold places in bulk or refuse a child just because the family doesn't live in the area yet
- Late applications will be treated as 'on time' as much as possible giving families flexibility

# Travelling to school: what to consider

Before applying for a school place, consider how your child will get there — safely and reliably.

### Walking (as long as there is a safe walking route)

- For children aged 4 to 7, the Government expects they can walk up to 2 miles
- For children aged 8 or older, up to 3 miles is considered reasonable.

### **Public transport**

- Check if there's a suitable bus or train route that lines up with the school's start and end times
- Consider access, wait times, and reliability, especially in poor weather

### Travelling by car

- Is there safe and available parking near the school?
- Be mindful to park considerately this protects children's safety and keeps things smooth for the wider community

### Active travel to school

Starting secondary school is a big step for your child — they'll begin gaining more independence. One way to support this is by encouraging them to walk or cycle to school. All secondary schools in Milton Keynes support this kind of active travel.

### Why walk or cycle?

- It helps your child become more independent.
- It builds healthy habits for life.
- It's better for the environment fewer cars, less pollution.
- It's a great way for your child to make new friends and enjoy the journey to school.

As your child begins this new chapter, it's a great time to think about how they'll get to and from school actively and safely.

# Parent/Carer declaration and signature

When you send in your school application, you'll be asked to confirm that:

- You've chosen and listed the schools in your preferred order.
- You are legally responsible for the child.
- Everything you've written is true, as far as you know.
- You understand that giving false or misleading information, or leaving things out on purpose, could cancel your application or take away a school offer.
- You understand that your home address will be checked using council tax records.

# Applying for a place outside of Milton Keynes if you are a Milton Keynes resident (relevant to Little Brickhill, Woburn Sands, Bow Brickhill, Hanslope, Castlethorpe and Stony Stratford)

### **Coordinated admissions - Apply through Milton Keynes**

- You must use the Milton Keynes application process, even if you're applying to schools outside the area.
- All schools use their own oversubscription criteria to decide who gets a place—check these carefully before applying.

### **Choosing your preferences**

- You can list up to four schools.
- It's strongly recommended to include your catchment school—this improves your chances of getting a nearby place.
- If you don't list any Milton Keynes schools and your outside-area choices are full, your child will be placed at a Milton Keynes school that has an available space in the year group, which may not be the catchment school.

### **Transport considerations**

- If your child is offered a place outside Milton Keynes, you're responsible for transport.
- Milton Keynes City Council does not provide transport to schools outside the area (except for High Ash CofE Primary School in specific cases).
- Talk to the local authority where the school is located to understand transport options.

### In-year admissions – Key information for Milton Keynes residents

If you're applying for a school place outside the usual entry points (like Reception or Year 7), here's what you need to know:

### **Applying for schools**

- For schools outside Milton Keynes, you must apply through the local authority where the school is located.
- For Milton Keynes schools, use the Citizen Portal on the Milton Keynes City Council website.

### Admission criteria and availability

- Every school uses its own oversubscription criteria to rank applications—check these before applying.
- In-year admissions depend on available spaces at the time of your application. If your chosen school is full, your child may not get a place.

### **Transport responsibility**

If your child is offered a place outside Milton Keynes, you must arrange transport.

Milton Keynes City Council does not provide transport to schools outside its area. You should discuss transport options with the relevant local authority before making your application.

You are advised to also apply for schools in Milton Keynes via Milton Keynes school admissions portal Citizen Portal. If your application is unsuccessful as many schools will already be full at this point, you will be allocated a place at a school with vacancy.

### **Applying to a University Technical College (UTC)**

If your child is interested in joining a UTC in Year 10, here's what you need to know: Available UTCs:

- Silverstone UTC www.utc-silverstone.co.uk
- Aylesbury UTC www.aylesburyutc.co.uk

### How to apply:

- Milton Keynes City Council publishes info about the usual admission points, but UTCs handle their own admissions directly.
- Milton Keynes City Council will write to all Milton Keynes residents of a Year 9 child in September, to inform them of the UTC's available in the area.
- To apply, you must contact each UTC individually they'll guide you through their application process and provide details about open days, deadlines, and entry requirements.

# Applying for school admissions outside your child's normal age group

As your council, we understand that every child's educational journey is unique. While it may seem helpful to delay a child's school start or keep them back a year,—known as admission outside of normal year group— we do not support this approach as a general practice.

### Why we advise against it

Educating a child outside their age group can lead to long-term challenges:

- School transitions may be disrupted if future schools don't agree to keep your child in a lower year group.
- Social and emotional development can be affected by being out of sync with peers.
- Academic progress may be slower than peers who receive targeted support.
- Post-16 education options may be limited due to age restrictions.
- Support may end early, especially in Year 11, when statutory school age ends.

### What we recommend

Support should be tailored within the child's current year group, including:

- One-to-one or small group teaching.
- Curriculum adjustments
- Emotional and social support
- Collaboration between families, schools, and professionals

If your child is gifted, experienced ill health, they have previously been educated out of their normal age group or has other reasons for needing to join a different year group than their age usually allows, you can request admission outside their normal age group.

### What you need to know:

- This request can be made if you feel it's in the best interest of your child.
- The final decision rests with the admissions authority for the school, which must make this decision on the basis of the circumstances of the case and in the child's best interests.

All schools must explain the process for this kind of request in their admission policies.

### How to make a request:

- Apply for a school place at the usual time (when your child is in Year 6) by the closing date.
- At the same time, submit a request form to Milton Keynes City Council. This is available on our website.
- Email your form and supporting documents to: secondaryadmissions@milton-keynes.gov.uk
- Milton Keynes City Council will forward your request to the school for their consideration.
- The school will notify you and the council of their decision






If you are moving house, you must provide proof of your new address by the closing date.

If a place is declined at a school of preference, your child's name will automatically be placed on the waiting list.
Waiting lists will be held until 31 December 2026
Appeal requests must be made direct to schools

# **Key Points to Remember**

There is no guarantee of a place at your catchment school.

We cannot offer your child a school until you make an application. You will not just automatically be given a school place.

Remember, if you are not sure about any part of the process just email or telephone us and we can give you more information and advice.

It is best to include your catchment school, even if you put it lower on your application than other schools.

This is because you may not get your school of preference and the catchment school may fill up with those who have applied.

Having a sibling
at the school does
not guarantee admission
but make sure you include
your other child's details on
your application, as it may mean
you are given
higher priority for a place.

You should list the schools in the order you would like them, not the order you think you might be offered them.

You are advised to list four schools.
Putting just one school doesn't give you a better chance of getting it.

# When to apply for secondary school

Applying for your child's secondary school place is easy and can be done either online or by using a paper form.

### **Important dates:**

- Online deadline: Submit your application by midnight on Friday 31 October 2025 at www.milton-keynes.gov.uk/schooladmissions
- Paper form deadline: Must arrive by 5pm on Friday 31 October 2025 by email or post.

### Need a paper form?

You can request one if needed at secondaryadmissions@milton-keynes.gov.uk

### **Extra documents:**

• Some applications may require supplementary forms — check what's needed before you apply.

All applications received by the deadline are treated the same — so take your time to visit schools and feel confident in your choices before submitting.

### How to apply

Starting from 2 September 2025, you can apply online at www.milton-keynes.gov.uk/schooladmissions

### Steps to apply:

- Create an account using your email as your username and choose a password.
- Complete the application and submit it.
- You'll receive an acknowledgement email confirming it's been received.
- If you don't get the email, log back in to confirm you submitted it correctly.

### **Key dates:**

- Online application closes at midnight on 31 October 2025
- Late applications will only be processed in April/May 2026

### **Editing your application:**

- You can view and amend your application up to the deadline.
- If you make changes, resubmit your application and parental declaration to ensure it's accepted.

### **National Offer Day:**

Log in again on 2 March 2026, if you applied online, to see which school place your child has been offered.

# Late applications

If you miss the main deadline (31 October 2025), your application will be processed after national offer day and you'll receive a notification in the later rounds.

### What happens with late applications:

- Your child won't be considered in the initial round of offers.
- They will be offered a place at the next nearest school with available space if a place cannot be offered at a preferred school.
- They will be automatically added to the waiting list for the preference schools that declined your child a place.

### **Waiting Lists:**

- Waiting lists are ranked by a school's oversubscription criteria.
- So even late applicants can move ahead of on-time applicants if they meet higher priority criteria.

# **Changing school preferences**

After the **31 October 2025** deadline, making changes to your school preferences isn't usually allowed — unless there are exceptional circumstances, and each case is judged individually.

### What you need to know:

- To make changes, you'll need to submit a new application, which will be treated as late.
- Late applications are processed after all on-time applications.
- Even if accepted, the council must follow the School Admission Code and each school's oversubscription criteria.

### **Limitations on changes:**

When submitting a late change of preference application:

- You cannot re-include:
  - A school that was already offered
  - Schools where your child is already on the waiting list
- You can only apply for:
  - □ New schools not listed originally
  - □ Lower preference schools from your original application

# **Processing applications**

Here's what happens after you submit your child's school application:

### **Between November and February:**

- The council shares your child's information with all the schools you've applied to.
- Foundation schools, Catholic schools, and academies sort applicants using their own admissions rules (called oversubscription criteria) and send their ranked lists back to the council.
- If you applied to a school outside Milton Keynes, that local council will follow its own procedures and let Milton Keynes know if a place can be offered.

### **Equal preference explained:**

- Schools do not know your order of preference.
- Each school considers your application fairly using their criteria it doesn't matter whether they were your 1st or 4th choice.
- If your child qualifies for more than one school, the council will offer the one highest on your preference list.

### How school distance is measured

When a school gets more applications than places (called oversubscription), priority is often given based on how close you live to the school.

### How the council measures distance:

- The council uses special computer software to measure the shortest route from your home to the school's main entrance gate.
- This might be different from online maps because the software uses local data and special codes for streets, redways, paths, underpasses, and junctions.
- Every home and school has a unique reference number used in these measurements.

Depending on the school's admission rules, they use one of two methods:

- **1. Straight-line distance** "as the crow flies."
- **2. Shortest route available** using actual paths, roads, and walkways.

No matter which method is used, all families are measured using the same system, to keep things fair and consistent.

### National Offer Day - 2 March 2026

This is the day when you'll find out which secondary school your child has been offered a place at. If you applied online:

- You can log into the council's website to view your offer.
- You will also get an automated email confirming which school has been allocated.

### What happens next:

You will receive an admissions pack from the offered school, with everything you need to get started. Didn't Get a Preferred School?

- If none of your chosen schools have space, your child will be offered a place at the next nearest school to your home address with availability.
- Their name will be added to waiting lists for any preferred schools that couldn't offer a place.

You'll be informed about your right to appeal the decision. Appeals need to be submitted directly to the schools.

# Accepting or declining a school place

### Happy with the offer?

No action needed if you are happy with the Milton Keynes secondary school that has been offered. If you're pleased with the school offer, you're automatically considered to have accepted it.

If you are a Milton Keynes resident and wish to accept a Buckinghamshire Grammar School, please contact the admissions team at Buckinghamshire County Council Contact school admissions | Buckinghamshire Council

### Declining the offer?

If you've made other plans for your child's schooling, just send an email to: secondaryadmissions@milton-keynes.gov.uk Be sure to include:

- Your child's full name
- Your child's date of birth
- The school they'll be attending in **September 2026.** The place will not be removed until this information is confirmed.

If you tell us you want to refuse the offered school place, we won't take it away right away. That's because it's our responsibility to make sure every child has a school place.

We can only remove the offer once you have found another suitable school and can confirm your child has a place there—this could be at either a state or independent school.

### What should you do?

We strongly suggest you keep this offer for now. While holding onto it, you can:

- Appeal for any schools you originally ranked higher.
- Apply to other schools you're interested in.

This way, your child keeps a guaranteed school place while you explore other options.

# Not happy with the allocated school?

It's completely understandable to feel disappointed if your child wasn't offered a place at one of your preferred schools. Fortunately, there are several steps you can take:

Sometimes a visit can change your view. It's a good idea to book an appointment with the allocated school and get a feel for the environment, teachers, and resources.

### **Waiting Lists**

Your child's name is automatically placed on the waiting list for any of your preferred schools that couldn't offer a place.

If a place becomes available in the late application rounds, you may be offered a place from that list automatically. This means it will replace the school place that was previously allocated.

### **Late Applications**

You can submit a late application to other schools that still have vacancies.

**Be aware:** All late applications are ranked according to each school's criteria — and they may receive other late applications too.

If a place is offered via a late application, it will replace your original allocation automatically.

### **Appeal**

If you still wish to pursue one of your preferred schools, you can submit an appeal. You need to contact your preference schools directly if you wish to lodge an appeal.

### **Appeal**

If your child did not get into one of your preferred schools, you can ask about the appeal process by contacting the school you wanted. You'll need to give them:

- Your child's name
- · Date of birth
- Your address

The school will then send you the appeal information by post or email.

### Important:

- Check each school's website to find out when appeal requests must be submitted.
- All secondary school appeals are handled by the schools themselves, using an independent service.
- A clerk from the appeal service will get in touch with you about your hearing date, which usually takes place during the summer term.
- You may also want to consider appeal guidance for parents: Advice for parents and guardians on school admission appeals - GOV.UK (www.gov.uk).

If your child has an Education Health and Care Plan (EHCP) and you don't agree with the council's school placement decision, you can appeal to the SEND and Disability Tribunal. For details, contact the SEND Casework Team at 01908 253414 or check the website page www.gov.uk/appeal-sen.

### **Waiting lists**

After National Offer Day on 2 March 2026, schools that are full will keep waiting lists.

If you've been offered a lower-preference school: Your child will automatically be added to the waiting list for any schools ranked higher—where a place was declined.

### How waiting lists work:

- Each school ranks children using their own admissions rules.
- Late applicants might be placed higher on the list than earlier ones, depending on those rules.
- Being on the waiting list does not affect your right to appeal.

**Positions can change:** Your child's position on a waiting list might go up or down if other children with a higher priority apply later.

Late application rounds: Between 2 March and 31 August 2026, places at higher-preference schools can still be given from the waiting list. If your child gets offered a position at a preferred school during this time, the move happens automatically.

### Don't want to stay on the list?

You must email the Access to Education team at: **secondaryadmissions@milton-keynes.gov.uk** Let them know if you want your child removed from any waiting list after National Offer Day. If you don't, your child may lose their current place if a higher preference offer becomes available.

### How long are lists kept?

Milton Keynes City Council will hold the waiting lists from 2 March - 31 August. After 31 August, schools will hold waiting lists until from 1 September 2026 - 31 December 2026. After that, contact individual schools to find out if they still manage one.

# Withdrawing offers of school places

If a school place is offered based on false or intentionally misleading information, the admission authority has the right to withdraw the offer. This includes:

- Falsely claiming to live in a school's catchment area
- Providing incorrect details about siblings, special needs, or custody arrangements
- Any other information that gives unfair priority over other applicants

### Why it matters

- Misleading information can deny a place to a child who genuinely meets the criteria.
- Secondary schools in Milton Keynes who are their own admissions authority have withdrawn offers in previous years where this has occurred.

# In-year applications - If your child needs to join a school part-way through the year:

Milton Keynes City Council helps coordinate in-year school applications for all secondary schools in Milton Keynes but does not make the admission decision for these schools.

### How to apply

- Apply online through the council's citizen's portal on the Milton Keynes City Council website
- Some schools may ask you to fill out their own application/ supplementary form.
- You can also contact some schools directly to apply, the list of schools is available on the council's website.
- Visit the council's in year admissions website for more information.

### How school places are offered

- Places are offered based on what's available when you apply.
- Popular schools are often full—even if you have moved into the catchment area for the school, it does not guarantee offer of a place.
- You can choose up to four preference schools on your application.
- If no places are available, we will offer a place at the nearest school to your home with availability.
- All decisions follow the School Admissions Code 2021, which means:
  - □ Schools must follow the same rules.
  - □ Places are offered based on each school's oversubscription criteria.
  - □ Local MPs or the council cannot change the outcome of your application.

### Appeal - unhappy with the offer?

School Admission Appeal Panels are independent and have the legal authority to consider your individual circumstances. They can overturn the school's decision if they believe the impact on your child outweighs the reasons for refusing the place.

- You will need to contact your preference schools directly if you wish to lodge an appeal.
- You may want to consider appeal guidance for parents: Advice for parents and guardians on school admission appeals - GOV.UK (www.gov.uk).

# **Applying for Sixth Form (Post-16 Education)**

All secondary schools must share how many students they'll accept into sixth form from other schools. You can find this information on each school's website or by contacting them directly.

Priority for current students: Students who already attend the school and are completing their GCSEs will be given priority for sixth form places, as long as they meet the school's entry requirements.

# **School Travel Support - Eligibility**

### **Parental Responsibility**

Parents and carers must ensure their children attend school regularly and travel safely to and from school.

### **Who Qualifies for Travel Support?**

Children of secondary school age (up to Year 11) may be eligible if:

- □ Aged 11 to 16
- Attend their catchment school
- ☐ Live 3 miles or more away (measured by the shortest safe walking route)

#### 2. Low-Income Criteria

- ☐ Receive free school meals or parents receive Universal Credit
- □ Attend one of the three nearest schools
- ☐ Live between 2 and 6 miles from that school

### **Important Area Exceptions:**

Milton Keynes City Council does not consider Walton High the nearest qualifying school for children living in:

Ashland, Willen, Glebe Farm,
Aspley Guise, Willen Park, Eagle Farm,
Aspley Heath, Salford, Wavendon,
Campbell Park, Hulcote, Woburn Sands

Children in these areas are not eligible for travel support to Walton High.

Children in Little Brickhill are only eligible if they meet the low-income criteria above.

### Privilege fare scheme

If your child is not eligible for travel support, you may apply to pay for a seat on a contracted school bus (if space is available). These seats can be withdrawn if needed for eligible children.



# Section F Glossary of terms and school categories

Some of the words or terms often used in admissions are explained below.

Admissions authority	The body responsible for setting and applying the admission arrangements for a school.
	This is either the Local Authority (for community and voluntary controlled schools) or the governing body/academy trust (for foundation and voluntary aided schools and academies)
Admissions criteria	Each admissions authority sets criteria, which are a list of rules enabling the applications to be put into priority order if the school is oversubscribed.
Allocation	The place given to your child at one of your ranked schools or, if that is not possible, an alternative school.  The council will write to you confirming the place. Following this, the school will provide you with further information about admission including details of induction days so your child gets to know his or her new school.
Appeals	An independent process that will consider your appeal case when a preferred school place has not been allocated.
Choice or preference	A parental preference for a particular school.  There is no right to choose a school. However, parents can state four ranked preferences for schools when submitting an application. If there are enough places at the highest ranked school all applicants will be allocated a place. If a school is oversubscribed your request may be refused and, if possible, a place offered at one of your lower ranked schools.
Co-ordinated admission scheme	All local authorities are required by law to co-ordinate admissions for all schools in their area for the main admissions rounds.
Feeder/Partner school	A primary or junior school identified in a school's admissions arrangements as a feeder / partner school. Some schools give a higher priority for admission if a child attends one of their named feeder / partner schools. Parents should check each individual school's admission arrangements.
Governing body	All schools and academies have a governing body, which often includes parents. Their key roles are setting strategic direction, ensuring accountability, monitoring and evaluation.
Home Local Authority	A child's home local authority is the authority in which they live, i.e. the authority to which council tax is paid.
In-area and out-area	A defined geographical area used to decide which applications are given priority to attend a particular school. This is known as a 'catchment area'.

Independent Admission Appeals Panel	A panel of at least 3 people who will decide whether or not to allow an appeal. The panel must be entirely independent of the admissions authority.
In year admissions	The term used when a parent requests a change of school for their child, at any time other than during the main admissions rounds.
Joint custody arrangements	Where the childcare arrangements are shared jointly between both parents.
Late applications	Applications made after the closing dates in the main admissions rounds.
Looked after children	Children who are in the care of the Local Authority as defined by Section 22 of the Children Act 1989.
Previously looked after children	Children who were looked after but ceased to be so because they were adopted or became subject to a residence order or special guardianship order.
Multiple births	Twins, triplets or other multiple birth group
Nearest appropriate school	The nearest school to your home with a place that will meet your child's educational need, this could be your catchment school.
Normal home address	The address where you live with your child or the address where your child lives with someone who has legal care and control of your child. Proof of such an arrangement will be required
National offer day	The date on which local authorities post letters to parents offering school places. For the 2026 main admissions round, national offer day for secondary places is 2 March 2026.
Oversubscription	A school is oversubscribed when the total number of applications received is higher than the number of available places in the year group requested.
	The definition of 'parent' in the Education Act 1996 includes:
	Both natural parents provided they are married to each other at the time of birth or subsequently;
Parent	<ul> <li>Any person who, although not a natural parent, has parental responsibility for a child or young person; and</li> </ul>
	Any person who, although not a natural parent, has care of the child or young person.
	The term 'parent' refers to anyone, including carers, who have parental responsibility for a child as set out in the Children Act 1989. For more information visit the government legislation website at www.legislation. gov.uk
Published admission number	The number of places each school has available to offer. Schools and academies must admit up to this limit each year if there are sufficient applications.

Sibling	A brother or sister of whole or half blood or any other child (including an adopted child) who permanently resides at the same address and for whom the parent also has parental responsibility.
	To be included as a sibling within the admissions rules the other child (sibling) should still be expected to be in attendance when the applicant child joins the school.
Shortest available route	The shortest available route between a preferred school and your normal home address.
	This will be measured using a computerised Geographical Information System (GIS). Measurements are either assessed by measuring distance in a straight line or by the nearest/ shortest available route, depending on the school's admission arrangements.
Supplementary form	A form that some admission authorities use to ask parents for extra information to support their application for a school place, for example a church school may ask for confirmation of regular attendance at church or a copy of a baptismal certificate.
Waiting list	A list of children held and maintained by the admission authority for a school, when the school or a particular year group in the school is full. Please see the waiting list section for detailed information.

# **School Categories**

Academy	A school where the board of academy directors set the admissions policy and is responsible for decisions about school admissions.
Community school	A school that is maintained by the Local Authority, which employs the staff, and sets the admissions policy and oversubscription criteria.
Foundation school	A school run by its own governing body, which employs the staff and sets the admissions policy and oversubscription criteria.
Voluntary aided school	These schools are mainly religious or faith schools. They are run by their own governing body, which employs staff and sets the admissions policy and oversubscription criteria.
Voluntary controlled school	These schools are mainly religious or faith schools. The local authority is responsible for running the school and sets the admissions policy and oversubscription criteria.
