Milton Keynes City Council ("the Council") in exercise of its powers under sections 1(1), 2(1), 2(2), 4(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

- 1. This Order shall come into operation on the day of 2025 and may be cited as "Milton Keynes City Council (The Council of the Borough of Milton Keynes) (Various Roads, West Bletchley) (Consolidation of Parking and Waiting Restrictions and Prohibition of Loading) Order 2002) Variation Order 2025".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, West Bletchley) (Consolidation of Parking and Waiting Restrictions and Prohibition of Loading) Order 2002 and form part of that Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Various Roads, West Bletchley) (Consolidation of Parking and Waiting Restrictions and Prohibition of Loading) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order: -

6. Item NW119 in Schedule 1 of the Principal Order is replaced by the following: -

MELROSE AVENUE AND DORCHESTER AVENUE, WEST BLETCHLEY NORTH-WEST SIDE AND SOUTH-WEST SIDE

- NW119 From a point on Melrose Avenue 87 metres north-east of its junction with Whaddon Way, for a distance of 137 metres in a north-easterly then north-westerly direction onto and along Dorchester Avenue
- 7. The following item is inserted into Schedule 1 of the Principal Order: -

DORCHESTER AVENUE AND MELROSE AVENUE, WEST BLETCHLEY

NORTH-EAST SIDE AND NORTH-WEST SIDE

NW207 From a point on Dorchester Avenue 39 metres north-west of its junction with Melrose Avenue, for a distance of 50 metres in a south-easterly then north-easterly direction onto and along Melrose Avenue
