

MILTON KEYNES CITY COUNCIL

(QUEEN ELEANOR STREET AND WATLING STREET (V4), MILTON KEYNES) (40MPH SPEED RESTRICTION) ORDER 2025

WHEREAS Milton Keynes City Council (hereinafter referred to as “the Council”) in exercise of their powers under section 84(1), (2) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (the Act of 1984) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order may be cited as “Milton Keynes City Council (Queen Eleanor Street and Watling Street (V4), Milton Keynes) (40 mph Speed Restriction) Order 2025” and shall come into force on the day of 2025.
2. No person shall drive any class of motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule 1 to this Order.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and the Schedule, it is the wording of the Schedule which shall prevail.
4. There shall be no exemptions from the provisions of this Order except for the emergency services and Special Forces drivers within the armed forces on operational duties.
5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Schedule 2 hereunto are hereby revoked or varied to the extent stated in that Schedule.

SCHEDULE 1

40 MPH SPEED RESTRICTION

QUEEN ELEANOR STREET AND WATLING STREET (V4), MILTON KEYNES

SL1 From a point on Queen Eleanor Street 240 metres east of its junction with High Street, Stony Stratford, for a distance of 7.04 kilometres to a point 340 metres south-east of its junction with Burchard Crescent, Shenley Church End, in a generally south-easterly direction along Queen Eleanor Street and Watling Street including the full circumference of Stony Stratford Roundabout, Galley Hill Roundabout, Kiln Farm Roundabout, Calverton Lane Roundabout, Whitehouse Roundabout, Crownhill Roundabout and Loughton Roundabout.

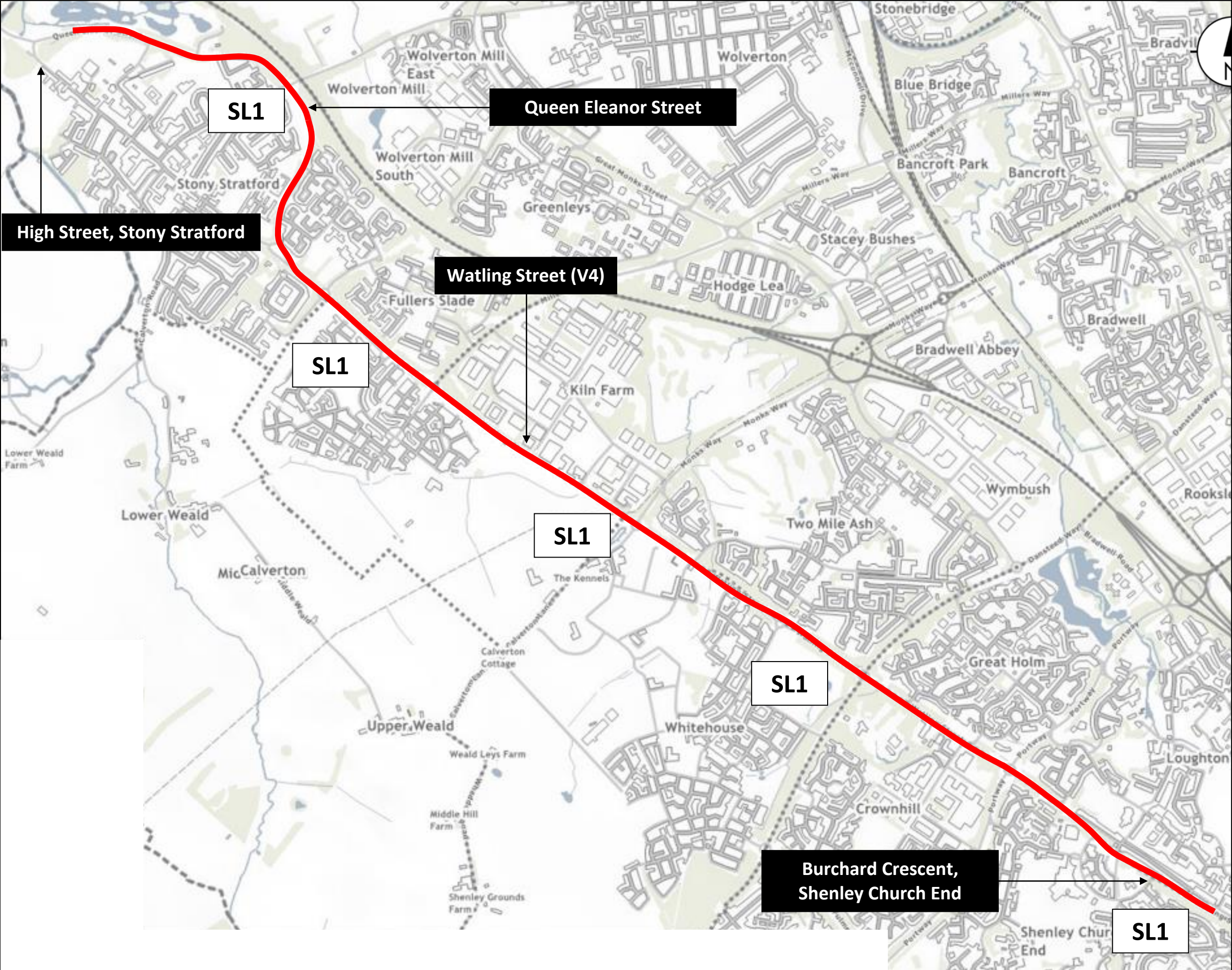


