- Where work in relation to a building has begun but not completed, and it is intended to carry out further work in
  relation to the partly completed work, sufficient plans to show that the intended work will not contravene any
  requirement in the Principal Regulations, including such plans of any part of the work already carried out, as may be
  necessary to show that the intended work can be carried out without contravening any such requirement.

#### 2 Charges

Please note that all Councils charge for this service, and the fee depends on the project and the time we spend ensuring compliance with Building Regulations. The correct charge applicable to this work will be determined on receipt of this form and the supporting information.

VAT is not incurred for Reversion application.

### 3 Validation
