Report Summary

This report provides a summary of the statutory consultation and the officer decision to consider any objections received during statutory consultation.

In recent years there has been a decline in the car share permit scheme resulting in an underuse of the car share permit only parking spaces in Central Milton Keynes.

On 26th November 2024, it was decided to remove the Car Share permit scheme from Central Milton Keynes and convert the 260 car share permit only parking spaces to standard or premium tariff parking.

The Council has 300 on-street free and limited waiting parking spaces in Central Milton Keynes, which attract congestion on the network, whilst motorists wait for spaces to become available. This also causes engines to idle, impacting on the environment and air quality.

Free parking undermines the Councils initiative to promote alternative modes of transport by making it easy for motorists to come to Central Milton Keynes through the provision of free parking.

On 21st March 2025 it was decided to convert 300 on-street free and limited waiting parking spaces in Central Milton Keynes to Standard and Premium tariff parking.

On 3rd April 2025, the Council served notice on the proposal to make two traffic regulation Orders.

The general effect of the proposed Orders is:

- to remove all existing car share parking places in Central Milton Keynes and replace with standard tariff and premium tariff parking places.
- to remove all existing free and limited waiting parking places in Central Milton Keynes and replace with standard tariff and premium tariff parking places.

Statutory consultation concluded on 24th April 2025.

Statutory Consultation

On 3rd April 2025, the Council served the notice of proposal which initiated 21-days of statutory consultation in accordance with the Road Traffic Regulation Act 1984 and Sections 6 and 7 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996.

The notice of proposal was served in the local newspaper CitizenMK.



Response Received

During the statutory consultation period the Council received **130** representations (as shown in Annex A to this report).





Objections (In summary)

- Removing the free parking could displace parking into neighbouring estates where it is free.
- Removing the free parking could result in people finding other places to shop where parking is free or shop online.
- O This puts a burden on people with low income.
- CMK was built around free parking.
- Local bus services are not adequate and therefore do not provide a suitable alternative.
- Retail parks offer free parking and therefore will attract the CMK Shopping centre customers.
- Parking is already too expensive in CMK.
- This is another opportunity for the Council to make money.
- Removing the car share permit will discourage the use of more sustainable and environmentally friendly transport options, contradicting wider goals of reducing carbon emissions and traffic congestion.

Formal Consideration

The Assistant Director Highways and Transport must now now consider the objections received during statutory consultation and make a decision whether to uphold any of the objections.

Options

After carefully considering all the objections received during statutory consultation, the Decision Maker must not decide on the following options:

Option 1	Do not uphold the objections and implement the changes as proposed on 3rd April 2025.
Option 2	Uphold the objections and not implement the changes as proposed on 3rd April 2025.
Option 3	Uphold the objections relating to part of the proposal and only implement the changes where the objections have not been upheld.
Option 4	Amend the proposals and re-consult.



Officer Response

It is the Officers opinion that the Councils reasons for making the proposed changes outweigh the reasons of the objections received.

The reasons for making the proposed changes not only align with the executive decision made on 26th November 2024, to discontinue the Car Share Permit, which has now been implemented, but to better align the cost of parking to the cost of the bus travel. The changes will also influence parking space turnover and regulate the supply and demand of parking spaces which will help improve congestion and local air quality in Central Milton Keynes.

Additionally, the Council is trying to rationalise its parking options to ensure that wider aims such as behavioural change of motorists (balancing up the public transportation option) or longer dwell times to support local businesses are also factors in these changes.

Decision

Accordingly, under my delegated powers, I have duly considered the objections received during statutory consultation and make the following decisions:

- 1) To not uphold the objections.
- 2) To proceed with the implementation of the altarations of the parking arrangements in Central Milton Keynes as proposed on 3rd April 2025.

			The proposed removal of all existing car share parking places, as well as free and limited waiting parking bays, and their replacement with standard and premium tariff parking spaces, is counterproductive for several reasons:
			 Undermining Sustainable Transport Initiatives The removal of dedicated car share bays directly contradicts environmental and transport policies that encourage shared mobility, reduce congestion, and lower emissions. Car sharing plays a crucial role in reducing private vehicle ownership and promoting sustainable urban transport. Eliminating infrastructure that supports this undermines the Council's own sustainability objectives.
			 Disproportionate Impact on Low-Income Residents and Visitors Free and limited waiting bays provide critical access for individuals who cannot afford premium or extended paid parking, including those on low incomes, volunteers, carers, and visitors conducting short errands. Replacing all such bays with paid tariff spaces introduces unnecessary financial pressure and limits inclusivity in the city centre.
			 Detrimental to Local Business Local shops and services benefit from short-term, free, or limited waiting bays which enable high turnover of visitors. The shift to entirely paid parking is likely to deter casual footfall, directly impacting small businesses and local commerce.

I am writing to express my concerns regarding the proposed changes to replace free car parking spaces with paid parking in the city centre of Milton Keynes. While I understand that changes to parking policies are sometimes necessary for urban development, I would like to raise several important points that I believe should be carefully considered before implementing this change.

1. Need for Free Parking for Short-term Visits

Free parking spaces are essential for individuals who need to make short visits to the city centre for brief errands, business, or appointments. For many residents and visitors, the option of free parking for a short period is crucial, as it allows them to quickly attend to necessary tasks without the financial burden of paid parking. Removing free spaces would create a significant inconvenience, particularly for those who may only need to park for a short duration.

2. Impact on the Cost of Living

Given the current economic climate, where the cost of living has already reached significant highs, any increase in parking charges is likely to further exacerbate financial pressures on local residents and visitors. This increase in costs could lead to reduced discretionary spending, which may ultimately harm businesses, shops, and services in the city centre. Many local enterprises rely on foot traffic from those who are able to park nearby without additional financial burden. The removal of free parking spaces could deter people from coming into the area, negatively impacting the local economy.

3. Limited Public Transport Options

It is important to note that public transport options in Milton Keynes are not as comprehensive as in some other cities. For many residents, particularly those who live in suburban or rural areas surrounding the city, traveling by car is often the only feasible option. In light of this, it is essential that there continues to be a supply of free parking spaces to accommodate those who depend on their vehicles for access to the city centre.

Other than that, the recent decision to double the parking fees for standard rate is questionable. While I understand that price adjustments are sometimes necessary to manage demand and contribute to the local budget, I have significant reservations about whether this change will have the desired effect of encouraging more people to visit the city centre.

In conclusion, I urge the council to reconsider the decision to replace free parking spaces with paid parking. The need for short-term parking, the financial strain on local people, and the reliance on cars due to limited public transport all suggest that maintaining free parking options is crucial for the well-being of Milton Keynes residents and businesses.

The new parking fee structure, which came into effect in March 2025, could potentially discourage local residents and visitors from coming into the city centre, especially given the current cost of living pressures that many are already facing. Increasing the cost of parking could result in fewer people choosing to drive into the city, leading to reduced foot traffic for shops, restaurants, and other local businesses that rely on customers who can park conveniently nearby.

I would like to ask whether the council has conducted any analysis to assess the potential impact of this fee increase on local shopping habits and overall city centre traffic. It seems that higher parking fees could create a barrier, particularly for those who need to make quick, short-term trips to the area. In turn, this could have unintended consequences, such as reducing the amount of time people spend in the city centre and diminishing the footfall that businesses depend on.

I appreciate that there are various factors involved in managing parking and ensuring adequate revenue for city services. However, I would encourage the council to explore alternatives that balance the need for revenue with the importance of maintaining a vibrant, accessible city centre. Perhaps there could be designated free or low-cost parking zones for short-term visits, which would still support local businesses without causing undue financial strain on visitors

(78)Member of the public 15th April 2025 I am writing in response to your consultation to parking charge changes in central Milton Keynes. Objection I am not responding to changes to car shares and permit parking, as I am not a user of these. I object to the removal of all free time-restricted parking, and the proposal to enforce a mandatory two hour minimum parking tariff. I am not opposed to a proportional increase in charge per actual hour spent (for example 50p per hour becomes 60p per hour). I am a Milton Keynes resident (stony Stratford), who manages to do much of her shopping locally, but sometimes needs to go to the city centre. I do not think you should be charging people excessively for essential visits. For example, having to pay a minimum of £2 to make a transaction at the bank (I have no online banking) or collect something from the chemist which is not stocked in either of our two local chemists, is clearly disproportionate. [I know it is not your fault that most banks have closed, but it is the main reason I now have to go to the city centre.] That is where the timed free bays are useful. The two or three hour bays also mean that I might have a look round other shops for fun, or have a coffee, which helps these businesses. I think charging a minimum of four hours so that someone can nip to the bank is wrong. I also think that charging a minimum of two hours if someone arrives at, say, 5.40pm is wrong. The fact that the hourly rate is 50p means that I don't mind paying it if I am early, but would object to £2 for 20 minutes. The other reason I am against no free slots is that I do not have 'apps' or the internet once outside the house. I am capable of paying by bank card but I cannot park anywhere with 'app' only parking, and I am not the only one without this kind of 'phone. [It is unclear on your proposal as to whether all charges would become app only.] When visiting the city centre, I often notice that the premium bays are not fully occupied - and I think one way forward might be to make these bays actually cheaper; I think your revenue might in fact increase overall. I rarely use the premium bays myself, because I am happy to park further away and walk up, and do not want to pay these prices for essential shopping. I know that cmk is a destination shopping centre for people who live in other towns; but for locals, it is useful to have the free parking, which is not always obvious, to carry out these everyday tasks. Related points: when parking charges were first introduced, the revenue was supposed to be dedicated to funding sustainable travel. I have not noticed this (if you have, it is not obvious). There is a large car park standing empty in the old food hall, and there seems to be another by the station. We have already lost the timed free parking in the food hall (not to mention the food hall itself). (And, for reasons I have never understood, you got rid of the very useful theatre car park - as a keen theatre goer, it was my favourite). I am aware that the former may no longer be in your control, but it is still annoying. To sum up: I object to the removal of the time restricted free bays, and I object to the mandatory two hour minimum charge of £2 in the 50p bays. - * Grounds:
- * Limited Engagement with Car Share Operators and Users: Has the Council adequately consulted with car share operators and their users to understand the potential impact of this proposal on their services and travel habits?
- * Lack of Engagement with Local Businesses: Have local businesses been consulted on the potential impact of removing free and limited waiting parking on their trade and customer access?

It may sound trivial, but I stop at the city every morning on my way to work to go to Starbucks to buy coffee and Pret to buy lunch. It takes me about 5-10 minutes each morning to do this, and it's only possible as I can quickly park (without incurring parking charges) to go in and spend money at the shops. I also do the same at M&S, dropping in two or three times per week for a brief shop, staying for around 10 minutes. If I have to pay each day to do this, I will no longer visit the city as wouldn't want to incur a parking charge each day I wish to grab a coffee and sandwich - this would make the cost of supporting those shops disproportionate and prohibitive.
