(THE COUNCIL OF THE BOROUGH OF MILTON KEYNES) (VARIOUS ROADS, GREAT HOLM) (PROHIBITION OF WAITING AND LOADING RESTRICTIONS) ORDER 2011) VARIATION ORDER 2025

Milton Keynes City Council ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

- This Order shall come into operation on the day of 2025 and may be cited as "Milton Keynes City Council (The Council of the Borough of Milton Keynes) (Various Roads, Great Holm) (Prohibition of Waiting and Loading Restrictions) Order 2011) Variation Order 2024".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Great Holm) (Prohibition of Waiting and Loading Restrictions) Order 2011 and form part of that Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Various Roads, Great Holm) (Prohibition of Waiting and Loading Restrictions) Order 2011 ("The Principal Order") is varied as provided by the following provisions of this Order: -

6. Item NW16 in Schedule 1 of the Principal Order, is replaced by the following: -

HADDON AND WADDESDON CLOSE, GREAT HOLM SOUTH-EAST SIDE AND SOUTH-WEST SIDE

NW16 From a point on Haddon 67.6 metres south-east of its junction with Highgrove Hill, for a distance of 42 metres in an north-easterly then south-easterly direction along Haddon and Waddesdon Close.

7. The following items are inserted into Schedule 1 of the Principal Order: -

HADDON, GREAT HOLM

NORTH SIDE

NW27 From a point 83 metres south-east of its junction with Highgrove Hill, for a distance of 20 metres in an easterly direction.

HADDON, GREAT HOLM

NORTH-WEST SIDE

NW28 From a point 110 metres south-east of its junction with Highgrove Hill, for a distance of 34 metres in a north-easterly direction.


WADDESDON CLOSE AND HADDON, GREAT HOLM NORTH SIDE

NW29 From a point on Waddesdon Close, 10 metres south-east of its junction with Haddon, for a distance of 10 metres in a north-westerly then north-easterly direction along Waddesdon Close and Haddon.
