*****GUIDANCE NOTES*****

Criminal Record Check

A criminal record check **must** be supplied with this form and be dated no more than three calendar months before the street trading consent application is made. **Unless** you are renewing a street trading consent and a period of 3 years has not passed from when the last criminal record check was provided to the Licensing Authority.

The Criminal Record Check can be in the form of either:

- i) A criminal conviction certificate issued under section 112 of the Police Act 1997 (obtainable from <https://www.gov.uk/government/organisations/disclosure-and-barring-service> Cost £21.50) or
- ii) A criminal record certificate issued under section 113A of the Police Act 1997 or
- iii) The results of a subject access search under the Data Protection Act 1998b of the Police National Computer by the National Identification Service (obtainable via the Police)

Proof of right to work in the UK

Proof of right to work in the UK **must** be supplied with this form. **Unless** you are renewing a street trading consent and Indefinite Leave to Remain (ILR) has been previously provided. (ILR) grants the right to live, work, and study in the UK without time restrictions, acting as a form of permanent settlement.

To prove your UK right to work, British/Irish citizens use a passport (even expired) or birth certificate plus NI number proof.
