Firstly I would reiterate the concerns expressed by cllr sam crooks about the impact of development east of the M1 on the adjacent existing estates. Please take my submission as including his.

Secondly Policy GS9

Policy GS9 supports development within the transit corridors, to support the viability of public transport. I absolutely support this, provided good quality homes can be produced. But some of this corridor lies within noise and air pollution zones in some cases. I do not support building homes in these zones. While the mitigation provided by law is sufficient to avoid

really major harm to health, it certainly does not avoid considerable discomfort and minor harm to health. If we are aiming to build healthy homes, then we should not support building in this zone. Officers have confirmed that the full number of homes envisaged is not essential for the soundness of the plan. There will also be infrastructure required such as parking for modal intersection, which could be provided within the pollution zone leaving the rest of the land for housing.
